OFFICE ORDER

In context of the ongoing corona virus outbreak in China and its rapid spread to many other countries including India, there are chances of initiation of local transmission and rapid spread of the disease in our State also. In order to control the transmission and spread of the disease, 3 pronged strategy viz: preventive, promotive and curative has to be planned and executed. 
