#### Background

Tender bids were invited from manufacturers/Suppliers/Dealers only for Rate Contracting of "A-Septic Labour & New Born Kit". Tender notice and tender condition was also made available on the website - <http://statehealthsocietybihar.org>. Notice Inviting Tender was advertised in Hindutan (Bihar), Dainik Jagran (Bihar), Hindustan Times (Delhi), Times of India (Mumbai), The Statesman (Kolkata), Business Standard (Hyderabad), Gujrat Samachar, Sandesh (Gujrat) dated 7.11.09. The last date of submitting of tender was on 26.11.09 by 3:00 PM. As per tender notice date & time of opening of tender bids was on Thursday i.e 26.11.09 at 3:30 PM. Prebid meeting of interested bidders was held on 16.11.09 at 11:00 AM in the conference hall of SHSB, Patna.

Following seven (7) technical bids along with financial bids, in separate sealed envelopes, were received by the last date and time of submission i.e 26.11.09 at 3 PM.

All the documents and papers submitted by all the seven bidders were evaluated and analysed by the members. The members of the committee found that in the technical bid none of the bidders have met with each and every conditions mentioned in the tender notice.







**Conclusion :-**

**The committee recommends that -**

M/s Medicure, Telegraph Colony, Kidwaipuri, Patna neither has submitted Minimum three years experience for supplying the Kit's item, Market standing in India of minimum 3 years, PAN card of the bidder and BIS (Bureau of Indian Standard) Certificate and also not fulfilling even the turnover criteria, as in the financial year 2008-09, their turnover is only 0.53 crore which is less than required minimum one crore.


Hence members of the Technical Committee declared M/s Medicure, Telegraph Colony, Kidwaipuri, Patna as technically disqualified.


The members of the technical committee also found that most of the bidders have submitted variable data/documents, which are not as per the tender. Therefore, the committee resolved that an opportunity should be given to those bidders who have not submitted the requisite papers with their tender.

In view of the above the members of the committee decided to give 10 days time to rest six firms to submit required documents. If any of the firms fails to submit the requisite documents listed against their names, they would stand disqualified at the technical stage and their financial bids will not be opened.

It was also decided that the decisions of the Technical Committee shall be put on the website of SHSB.


The final decision on the technical bids of A-Septic Labour and New Born Kit will be taken in the next meeting of the Technical Committee after due date of submission of the requisite documents by the 6 bidders.




