




For printing of Badhai Cards, advertisement brought out by SHSB Patna in main Hindi Newspapers and Telegraph (English, Kolkatta Edition), Times of India(Delhi & Bihar Edition) and Hindustan Times (English, Bihar Edition) Newspapers and also in State Health Society, Bihar Website were uploaded. In response 8 tenders were received. Technical bid received were opened in the presence of committee members & the agency representatives & got signed by all of them.


A Technical comparative chart was prepared and was placed before the committee members for evaluation.

5 tenders were found technically qualified, remaining three agencies namely: Shree Lakshmi Press, Sanjay Printing Works & Ad-vantage have not attached the proof of three phase power supply (list enclosed), hence the agency were declared disqualified by the Technical Committee.

It was suggested that Financial bid - Cover - B of 5 bidders who qualified in the technical bid be opened for deciding the rates for printing of Badhai Cards. Sample of Badhai Card furnished by the agency will be decided at the time of opening of Financial bid.
