Project Description

State Health Society Bihar is implementing the National Rural Health Mission (NRHM) to improve the availability of and access to quality health care for people.

Tender Bid is invited from interested Companies/Firms/Agencies/Institutions/Individuals for 'Setting Up Dental Clinic through Public Private Partnership (PPP) in all Sadar/Sub Divisional Hospitals of Bihar.

Project Area - Every District Head Quarter of Bihar

Project Scope - To operate, maintain **Dental Clinic** in all Sadar/Sub Divisional Hospitals of Bihar.

Project Condition -

- The State Government will only provide space for **Setting Up Dental Clinic**
- The agency has to provide everything from equipments & machine, logistics, consumables etc to personnel along with space for storage at a nominal monthly rent payable to the SHSB of the concerned district by the agency.
- The agency has to ensure the installation, maintenance, functioning with provision of expert technical manpower.
- Rates (to be charged from the users) shall be applicable as per the list enclosed

Project Time frame- The project would be initially for five years. Depending upon performance further extension will be considered.

Dental Clinic should be setup with following minimum facility.

Other Facilities To Be Ensured - Round the clock necessary power back-up

Minimum Eligibility Criteria :

For Agencies:

- a. The intending body should have a minimum average annual turnover as given in table below in the last three years.

No. of Units proposed to be taken	Minimum turn over requirement
For 1 Unit	Rs. 1.25 Lakhs
For 2-5 Units	Rs. 3 Lakhs
For 6-10 Units	Rs. 5 Lakhs

- b. A market standing of minimum 3 years in the area of Dental Clinics.
- c. Must not be blacklisted by any agency or pending case either Civil or Criminal against them.
- d. A demonstrated ability of handling Dental Clinics..

For individuals:

- e. Doctors holding degree of B.D.S. may also apply. For individuals the criteria of turnover and market standing shall not apply.
- f. **Earnest Money:** Demand Draft of Rs. 2,000/- (refundable) in favour of State Health Society, Bihar.
- g. Whether proposal has been made under individual category or through companies firms/Agencies/ Institution Please specify clearly.

Note:- Minimum Eligibility Criteria no. 'a' shall be relaxed for individual bidder.

- ☆ Incase of Individual only one location can be provided.

Please Note : Incase the H1 party is unable to provide the services, the SHSB shall reserve the right to award the bid to the other bidders at the H1 rate.

Submission Requirements - Interested Agencies/Firms/Institutions/Companies/Individuals, wishing to undertake the above task on behalf of State Health Society Bihar, may submit, **in two separate sealed large envelopes** marked "**Tender bid for Setting Up Dental Clinic in all Sadar/Sub Divisional Hospitals of Bihar - Technical Bid**" and **Tender bid for Setting Up Dental Clinic in all Sadar/Sub Divisional Hospitals of Bihar - Financial Bid**". If both financial and technical bids are received in the same envelop, the tender bid shall be automatically rejected.

You are requested to clearly indicate each of the submission requirements mentioned below along with the relevant page number in your cover letter/ application accompanying the technical proposal.

The **Technical Bid** should include the following -

- (i) Approach to the project along with the services
- (ii) Treatments/Equipments/Manpower to be provided
- (iii) Capability Statement, in not more than two A4 pages
- (iv) Background of the firm/organisation with relevant experience, in not more than two A4 pages
- (v) Summary of the equipments proposed to be set up
- (vi) Summary of personnel, key clinical staff proposed .
- (vii) Annual turnover with details and audited annual report for last 3 years
- (viii) Demand Draft of Rs. 2,000/- (refundable) in favour of State Health Society, Bihar. Any bid not accompanied by earnest money will be automatically rejected.
- (ix) No-conviction certificate for the last three years submitting affidavit from Magistrate that they are not blacklisted by any Govt. Dept./Govt./Ministry or that there is no pending case in any Court of Law

Evaluation of Technical Bid:

- (i) Technical bids not accompanied with requisite equipment details would not be accepted.
- (ii) The firm needs to satisfy the Minimum Eligibility Criteria to be considered technically qualified.

Financial Bid envelop should only contain the Monthly Operational Rental being offered with the Government/SHSB.

The Financial Bids may be given in the following format:

The agency offering the highest monthly operational rental shall be awarded the contract.

Submission of tender -

The tender should reach the office of the State Health Society Bihar by 5.00 pm on 02.06.2008 through Registered Post/Courier/Speed Post. Tender bids received after this time, would not be entertained. The technical bids will be opened on 03.06.2008 at 04:00 PM in the presence of bidders or their authorised representative who desire to be present.

In case the short listed Company/Firm/Agency/Institution declines to take-up the project after being awarded the contract, it would be barred from applying for any project of any kind in State Health Society Bihar for a period of 3 years from the date of award.

The decision of the State Health Society Bihar shall be final, and no enquiries, or application for review, shall be entertained. The State Health Society Bihar reserves the right to cancel or reject any tender without assigning any reason.
