**NOTICE INVITING TENDER**

**Inviting reputed Companies/Manufacturers/authorized supplier for bids for installing Iron Rack (Shelf) and other minor necessary structure for Drug Storage of TB Division.**

**Background-** The T.B. Division of State Health Society, Bihar invites bids from a reputed Companies/manufacturer/authorized supplier for installing Iron Rack (Shelf) and other minor necessary structure for Drug Storage as per guidelines of RNTCP.

**Site of Installation** - In the campus of State TB Centre, Agamkuan, Patna (In the existing building of Medical Store).

**Description of Work :**

**(A) Dimensions** -Maximum 6 cartons will be stored in one shelf i.e. 3 cartons will be kept in a row and 2 cartons will be stacked one above the other. The clear dimensions of one storage shelf will be 1.425 meter long x 0.5 meter deep (front to back) x 0.65 meter high with load capacity of around 150 kgs. per shelves.

**(B) Material for construction** - Storage shelves will be made using 40 millimeter bore medium quality (external diameter 48.3 millimeter) mild steel pipes / 2" x 2mm slotted angles. These pipes / angles shall be embedded at least 10 centimeters into the existing walls and grouted in concrete to create horizontal shelves. Vertical pipes shall be provided as shown in the drawings. Base plates measuring 7.5 x 7.5 centimeter x 2 millimeter thick shall be provided under all vertical pipes at the floor level. All pipes shall be welded properly and secured to create a stable shelving system.

**Submission Requirements:** Interested Companies/Manufacturers/authorized supplier wishing to undertake the above task may submit the tender in a large envelop marked "Tender bid for Iron Rack (Shelf)". This large envelope will contain two separate sealed envelopes- One for their Technical bid marked as cover-A and another for their Financial bid marked as cover-B. You are requested to clearly indicate each of the submission requirements mentioned above in the cover letter/application accompanying the technical proposal. Each page of the Technical Proposal should be serially numbered. The cover letter should be accompanied with an item wise index and page no. also.

**Technical Bid:**

*The Technical Bid envelope should include the following papers.*

1. Name and Address of the Company/Manufacturers/authorized supplier.
2. Registration Certificate of the firm.
3. Manufacturing License of the product, Product Name, Make.
4. Authorization from Manufacturer confirming C & F/ Distributorship etc.
5. Technical literature and Catalog confirming the required specification.
6. Certificate of Sales Tax Registration.

**Prequalification Criteria:-**

1. The principle company wishes to apply through local dealers or channel partners a Authorization letter should be addressed to the tender committee through the dealers or channel partners.
2. The equipment must have warranty for 24 months from date of installation at site.
3. A minimum turn over of the Company/Manufacturer/ authorized supplier must be 10 Lakhs per year.

**Terms of Tender:**

1. The firm should provide a minimum 2 years warranty for the product.
2. The final price quoted should be inclusive of all taxes.
3. Rate quoted should be inclusive of installation charges.
4. Rate quoted should be inclusive of all transportation costs of taking the item to the site for installation.

**Financial Bid**

The financial bid must be given in following format.

**Earnest Money:-** Bidder will be required to deposit 5,000/- security/tender money (Refundable) in the firm of demand draft favouring TB Division, State Health Society Bihar as EMD.

**Deadline for submission of Tender:**

The bids in sealed envelope shall be submitted to the TB Division, State Health Society, Bihar, Pariwar Kalayan Bhawan Sheikhpura, Patna on or before 23 June 2008. Bids received after this time, would not be entertained.

**Opening of Bids:-**The technical bids shall be opened on the 25 June 2008 in the presence of bidders or their authorized representative who desire to be present, and would their after be evaluated. The financial bids of only those tenderers will be opened whose technical bid is found eligible by the committee. The State Health Society, Bihar reserves the right to reject any or all tender without assigning any reason thereof.

**For information of the Bidders:-** The awarded supplier has to ensure supply within the stipulated time period, or else suitable action shall be taken against them.

The selected company/firms will be immediately inform about the final award. In case the selected company declines to take-up the purchase orders on the quoted and approved rates, it would be barred from applying for any tender from Government of Bihar for a period of 3 years from the date of award.
