Background

As per resolution taken by the Core Committee in its meeting held on 29.1.2010 that some reputed firms who have not submitted the requisite documents should be given again an opportunity to submit the requisite paper these firms must possess such documents. The firm should be given 10 days time to submit the papers and should be informed telephonically by SHSB Accordingly, these firms were informed telephonically to submit the same latest by 8.2.2010 i.e. before the next Core Committee meeting scheduled on 9.2.2010.





Members of the core committee under the Chairmanship of the Representative of Director-In-chief, Health Services, Bihar evaluated and scrutinized the papers and documents submitted by the firms according to the final comparative charts of technical bid prepared for all four categories by the Licensing Authority and Drugs Inspector deputed at SHSB and the Core Committee prepared a list of Qualified agencies/firms indicating their licence numbers, their products and disqualified agencies with cause of disqualification for all the four categories A,B,C, & D which is attached with this minutes as Annexure- 1, 2, 3, 4, 5, 6, 7 & 8.


After thorough scrutiny and evaluation of final comparative chart, the Core Committee resolved that -


1. Xerox copies of the papers and documents submitted by the firms will also be considered even though it has not been attested by any Gazetted Officer, in view of the fact that large no. of firms have submitted the Xerox copies of the papers which are unattested.
2. That the Batch Production Capacity Certificate should be issued by the Concerned Licencing Authority, but in some cases it has been issued by their Quality Assurance Department or Chartered Accountant. It was resolved that the Batch Production Capacity certificate issued by other than the concerned Licencing Authority shall not be accepted.
3. It was informed by the office to the members of the Core Committee that M/s Jackson laboratories Limited Amritsar and M/s Ind Swift Limited Haryana have been de-registered by Medical Store Organization, Directorate General of Health Services, Govt. of India and due to this no rate contract is being made with these two firms in the Vth & VIth round of Drug Rate Contract Tender.


The Core Committee resolved that decision in this regard is to be taken by the Society itself and as such the tender of these two companies are put on hold till further order in this regard.



4. Those bidding Firms who have applied for renewal of licenses have also been considered as per the order passed by Hon'ble High Court Patna in CWJC No. 4946/09 and also as per the Rule 72 and 77 of the Drugs and Cosmetic Act 1945, their licences are valid till the licence is renewed or cancelled by the concern licencing authority.
5. The firms/companies, who have submitted all the required documents will stand qualified on technical grounds subject to the site inspection and physical verification of their manufacturing unit.
6. In the next meeting of the Core Committee, the technically qualified Companies shall be assessed as per the physical site inspection and documents verification reports of their manufacturing premises/units and final recommendation for opening of financial bids shall be made to PAC.
7. Based on the above the members of the Core Committee Committee declared the bidders mentioned in Annexure 1, 3, 5 and 7 as "Technically Qualified" subject to the report of site inspection & physical verification of their manufacturing premises. Accordingly the Core Committee also declared some of the bidders as "Technically Disqualified", as they did not fulfill all the criteria of the tender condition. The list of such bidders are as per the Annexure No.- 2, 4, 6 & 8

8. All annexure referred in this minute is signed by the members of the Core Committee.
9. In view of the decision of Core Committee in its meeting held on 3.8.2009-Drug Tender Round- VI, the Committee also resolved that :
  - (a) Companies which are technically qualified and whose physical site inspection and documents verification have never been carried out before by SHSB, physical site inspection and documents verification shall be carried out for such companies..
  - (b) Companies which are technically qualified and whose physical site inspection and documents verification have been carried out more than three years ago i.e. prior to Drug Tender Round-IV (year 2007), afresh physical site inspection and documents verification should be carried out for such companies.
  - (c) Companies which are technically qualified and whose physical site inspection and documents verification have been carried out for Drug Tender Round-IV or V or VI i.e. within three years, no physical site inspection and documents verification is required for such companies.

The Committee requested the State Drugs Controller, Bihar to do the needful in regard to sub-para (a) and (b) of para-9 above.

10. It was decided that resolutions along with all Annexures will be published on the web site of the SHSB for bidders notice and information.
