## **NOTICE INVITING TENDER**

**Inviting tender From Govt./Non. Govt. Manufacturers for Rate Contracting of Umbrella for Accredited Social Health Activist (ASHA) in Bihar.**

### **Project Description**

State Health Society Bihar is implementing the National Rural Health Mission (NRHM) to carry out necessary corrections in the basic health care delivery system. The Goal of the Mission is to improve the availability of and access to quality health care by people, especially for those residing in rural areas. As part of its overall mandate of ensuring accessibility to good quality healthcare in villages and also the goal of the programme is to provide One Umbrella to each ASHA of the State to improve the motivation and dedication of ASHA.

The State of Bihar intends to procure good quality Umbrellas for all ASHA workers in 38 Districts of Bihar. The State intends to provide Umbrellas to approximately 87135 ASHAs.

**Minimum Eligibility Criteria** -The intending body should meet the following criteria :-

- A minimum average annual turnover of Rs. 5 (Five) Crore in the last three consecutive financial years 2007-08, 2008-09 & 2009-10.
- PAN Card No.
- Income Tax Return for Assessment Year 2007-08, 2008-09 & 2009-10 (Mere C.A. Certificate will not be sufficient).
- Sales Tax Registration
- Must not be black listed by any agency or pending case either Civil or Criminal against them.
- Bidders will be required to deposit Rs.20,000/- (Rs. Twenty thousand only) (Refundable) in the form of Demand Draft favoring "Executive Director, State Health Society Bihar, Patna" as EMD.

### **Submission Requirements** -

Interested Govt./Non. Govt. Manufacturers/Weaver Co-operative Society may submit their tender in a sealed envelop marked "Technical bid for Umbrellas for ASHA" which will contain all the following mentioned necessary documents :-

- Audit report of last three consecutive financial years 2007-08, 2008-09 & 2009-10
- Copy of Pan Card.
- Income tax certificate for Assessment Year 2007-08, 2008-09 & 2009-10 (Mere C.A. Certificate will not be sufficient).
- Sales Tax Registration Certificate.
- Affidavit - Self/Notarized stating that it is not black listed by any agency or has pending case either Civil or Criminal against them.
- EMD of Rs. 20,000/-

**Evaluation of Technical Bid:** The Minimum Eligibility Criteria for being technically qualified is as follows -

**Tender conditions**

- a) A Pre-bid meeting will be held on 18.05.2010 with the intending bidders at 11 AM at the conference hall, SHSB, where in the approved sample of Umbrella as selected by the technical committee of SHSB will be displayed.
- b) The bidders will be required to submit one sample of Umbrella on the basis of the technical specification advertised and the Umbrella displayed in the pre-bid meeting along with technical documents. The technical specification is as below:-

- c) The technical bid will be opened on 27.05.10 will be opened where in one sample will also be selected as submitted by the bidders.
- d) The selected sample will be sent for technical specification to the testing lab .
- e) The manufacturers /Weaver Co-operative Society which fulfill the minimum technical eligibility criteria will be invited to submit financial bids.
- f) The agency who has the L1 rate will be asked to supply the Umbrella. Any other agency willing to supply Umbrella to some other districts or part of the State may be asked to do so on the L1 rate, if the L1 agency is unable to provide the Umbrella to all the 38 districts but it will be at the sole discretion of SHSB

- g) The successful Agency will have to furnish a suitable Performance Security of 10% of the project cost at the time of awarding the rate contract for the period of the contract. The proceeds of their Performance Security shall be payable to SHSB as compensation for supplier's failure to fulfill its obligation under the contract or for making delay in the completion of obligations under the contract. The selected agency will be immediately informed about the final award. In case the selected agency declines to take-up the task henceforth from SHSB at the quoted and approved rates, it would be barred from applying for any tender from the State Health Society Bihar
  - h) The agency will be provided the list of Districts along with the no. of Umbrella required for each of the Districts. The agency will provide the targeted no. to each of the Districts.
  - i) It will be the sole responsibility of the agency to supply the Umbrellas to concerned District Head Quarter at their own cost.
  - j) The concerned DHS will buy the Umbrellas from the respective selected agencies as per the target and make 70% of the payment immediately on the date of receiving the consignment.
  - k) 5% of the received consignment randomly selected will be sent for quality testing by DHS. On the basis of quality test report received, the rest of the 30% payment will be made to the agency, if satisfactory as mentioned by the report. If, the Quality is not satisfactory, the agency will have to take back the consignment at own cost and replace it with a new consignment and the same procedure will be followed.
  - l) All the Umbrellas are to be made available by the selected agencies to the District Health Society before 30.09.2010 Penalty will be levied for delayed supply (0.5% per day of bill amount of delayed supply), which shall be deducted from their bill or Performance Security Money. .. In case, the company is found to be habitual defaulter (5 orders) of delay supply or not supplying the full quantity in time, the balance amount of performance security shall be forfeited.
  - m) Torn, Mutilated, Damaged Umbrella shall not be accounted for the purpose of supply and no charges will be paid for its replacement etc. Replacement within 15 days with no extra cost is the responsibility of agency.
  - n) Risk and liability and insurance up to delivery at DHS will be of the agency.
  - o) Transportation free of cost up to District Head Quarter would be the responsibility of the agency.
  - p) SHSB reserves the right to have the consignment inspected at any point to ensure the quality of the product. The produced material must match with the sample Quality.
  - q) The rate contract will be applicable for two years from the date of award of the contract.

The list of L1 Agency will be finalized at the State Health Society Bihar. After being awarded the contract, the awardee will be required to be registered with the Bihar Sales Tax.

**Deadline for Submission of tender -**

**The technical bid in a sealed envelope, along with the necessary documents & EMD along with one sample of Umbrella must reach the office of the undersigned latest by 3.00 PM on or before 26-05-10 through Post/Courier/Registry. Tenders received after this deadline, would not be entertained. In the event of the specified**



deadline of submission of tenders being declared a holiday, the tenders shall be received on the next working day. (294)

**Opening of Tenders –**

Tenders shall be opened at 4 PM on 27.05.10 in the presence of Agency or their authorized representative who desire to be present, and would thereafter be evaluated by a committee. On basis of the technically qualified tenders, the successful agency will be asked to submit their financial bids within three days.

The decision of the State Health Society Bihar shall be final, and no enquiries, or application for review, shall be entertained. The State Health Society Bihar reserves the right to cancel or reject all or any tenders without assigning any reason.
