# ADVERTISEMENT FOR INVITING APPLICATIONS FROM NGOs / CBOs FOR EMPANELMENT

The Government of India has received a Credit (Credit-4299-IN) from the International Development Association (IDA) and a grant from the Department for International Development (DFID), U. K. in various currencies towards the cost of the Third National HIV/AIDS control Project and it is intended that a part of the proceeds of this credit/grant will be applied to eligible payments under the contract for which this invitation for consultancy is issued. The project is an intervention with a goal of reducing the burden of HIV / AIDS cases in the country. The components of the project are prevention, care and support and treatment, programme management and strategic information management with one of its sub-components being targeted interventions for high risk groups, as well as utilizing civil society organizations for providing access of vulnerable populations to various HIV / AIDS interventions. It is proposed that applications would be invited from interested civil society organizations in the State of BIHAR for empanelling themselves to (a) implement HIV / AIDS targeted interventions with highly vulnerable population groups (b) work in providing access to HIV / AIDS interventions like care and support, people living with HIV / AIDS and other vulnerable groups.

CBOs / NGOs that are registered societies / trusts and active in community work at the following districts Araria, Kaimur (Bhabhua), Bhagalpur, Bhojpur, Buxar, East Champaran, Patna, Purnia, Sitamarhi & Vaishali are eligible to apply. Applications in the specified format need to be submitted **on or before 7 days** from the date of publication of advertisement in the newspaper, by 5 pm.
