Project Description

State Health Society Bihar is implementing the National Rural Health Mission (NRHM) to improve the availability of and access to quality health care for people.

Tender Bid is invited from interested Companies/Firms /Institutions for 'Setting Up and Operationalising 0.2 Tesla MRI machine through Public Private Partnership (PPP)' in DMCH.

Project Scope – To operate, maintain and report 24-hours **'0.2 Tesla MRI machine'** in Darbhanga Medical College & Hospital, Laheriasarai, Darbhanga and report the progress to the Superintendents (who would be incharge of monitoring the MCH project) and the SHSB.

Project Condition -

- DMCH will provide suitable space in the premises of DMCH and allotment of space shall be at the discretion of the Superintendent-DMCH. The agency has to give a nominal monthly rent payable to the Rogi Kalyan Samiti of DMCH.
- The agency has to provide MRI machine (henceforth referred to as Radiology C)– 0.2 Tesla fully loaded 8 to 24 channels. Machine/equipment installed should be suitable for the MCH level. The equipment being installed should cover and ensure all the basic/advanced tests/services undertaken through MRI machine.
- The agency has to provide everything from equipments & machine, logistics, consumables etc to personnel, necessary power back-up, bear cost of electricity and water supply, etc.
- The agency has to ensure the installation, maintenance, functioning with provision of technical expert.
- manpower round the clock.
- The agency shall be responsible for getting proper license from the competent Authority for running the MRI machine.
- Rates (to be charged from the users) shall be applicable as per AIIMS, New Delhi for the tests done through MRI.
- Agency to pay percentage gross revenue share to the Government on a monthly basis, again payable to the RKS of the MCH. Gross revenue shall be the total revenue generated in the MRI centre at DMCH on account of any services provided/generated there.
- The agency may be required to upgrade the machine to 0.5 or 1.5T MRI machine within the project period to meet the MCH requirements.

Project Timeframe- The project would be initially for five (5) years depending upon performance further extension will be considered.

Minimum Eligibility Criteria -

- ✓ The intending body should have a minimum average annual turnover of Rs. 1 Crore or above in the last three years.
- ✓ A market standing of minimum 3 years in the area of Radiology/MRI manufacturing/operation.
- ✓ Possess Service Tax certificate.
- ✓ Must have/ensure qualified human resource for the task
- ✓ Must not be blacklisted by any agency or have any pending case either Civil or Criminal against them.

If both financial and technical bids are received in the same envelop, the tender bid shall be automatically rejected.

You are requested to clearly indicate each of the submission requirements mentioned below along with the relevant page number in your cover letter/ application accompanying the technical proposal.

The Technical Bid should include the following -

- (i) Background of the firm with relevant experience (in the form of testimonials from clients)
- (ii) Registration Paper of the firm/organisation
- (iii) License for operating MRI machine from AERB with latest license renewal certificate
- (iv) Approach to the project- Details of the equipment/MRI machine proposed to be set up, Technical manpower proposed, Tests to be provided through MRI
- (v) Annual turnover with details and audited annual report for last 3 years
- (vi) Copy of Service Tax certificate
- (vii) No-conviction certificate for the last three years submitting affidavit from Magistrate that they are not blacklisted by any Govt. Dept./Govt./Ministry or that there is no pending case in any Court of Law
- (viii) Undertaking to setup and operationalise the MRI machine at DMCH latest by last week of February 2010.
- (ix) Demand Draft of Rs. 5,000/- (refundable) in favour of State Health Society, Bihar.

Evaluation of Technical Bid: The firm needs to satisfy the Minimum Eligibility Criteria to be considered technically qualified.

Financial Bid envelop should only contain the Percentage of gross revenue share being offered with the Government/SHSB for setting up and operationalising MRI machine and services at DMCH. Incase the H1 gross revenue share party is unable to provide the services, the SHSB shall reserve the right to award the bid to the other bidders at the H1 rate.

Submission of tender -

The tender should reach the office of the State Health Society Bihar latest by 5.00 pm within 15 days of publication of this tender through Registered Post/Courier/Speed Post. Tender bids received after this time, would not be entertained. The technical bids will be opened the very next day of the tender closing date at 11 AM in the presence of bidders or their authorised representatives who desire to be present.

In case the shortlisted Company/Firm/Institution declines to take-up the project after being awarded the contract, it would be barred from applying for any project of any kind in State Health Society Bihar for a period of 3 years.
