


### Background


Bids for Drug Round-VII in four different categories i.e. A, B, C & D were invited in a single tender notice from eligible direct Pharmaceutical Manufacturers/Direct Importers for rate contracting of Drugs, other equipments/disposable material etc advertised in Hindustan (Bihar), Dainik Jagran (Bihar) Hindustan Times (Delhi), Times of India (Patna, Mumbai, Ahmedabad), The Statesman (Kolkata), Indian Express (Mumbai), Business Standard (Chennai, Hyderabad), Gujarat Samachar (Gujrat), Sandesh (Gujrat) on 3.10.2009. The last date for the submission of tender was 30.10.2009, by 12:00 Noon. Category wise list of drugs and tender condition was made available on the SHSB's website- [www.statehealthsocietybihar.org](http://www.statehealthsocietybihar.org). Prebid meeting of interested bidders was held on 14.10.2009 as per date fixed in tender notice.


Altogether 95 (ninety five) technical and 95 (ninety five) financial bids, in separate sealed envelopes were received by the last date of receiving tenders i.e 30.10.2009. All 95 (ninety five) technical bids of all four categories A,B,C,D were opened by the Core Committee on 30.10.2009: at 2PM in presence of bidders or their authorized representatives.


Separate comparative chart of the technical bid of all four categories were prepared by the Licensing Authority and Drugs Inspector deputed at SHSB as a technical expert by the office of State Drug controller, Bihar. On the basis of Comparative Chart, technical evaluation of all the tenders was carried out by the Core Committee in its meeting held on 15.12.2009. The core committee found that some of the bidders have not submitted each and every required documents/papers as mentioned in "Submission Requirement" column of Tender Notice with their Technical Bid. The committee also felt that bid rejection on these ground shall not fulfill the mission of Drug Rate contract, as, terms of Drug rate contract of Round-V is valid till 31.3.2010 only. In such circumstances drug rate contract of drug tender round VII have to be completed before 31.3.2010 Otherwise after 31.3.2010 there will be crisis of drugs in the Hospitals, Health Institutions. Therefore, it was decided in the meeting that in public interest and to achieve the mission & Goal of Drug Rate Contract, an opportunity should be given to those firms who have not submitted some of the required documents/papers along with their tender bid to submit the relevant required documents within 10 days from the date of issue of the letter in this regard. Accordingly, those companies were given an opportunity to submit the same latest by 19.1.2010 at 5PM vide SHSB's letter no 13923 to 13946, 13960 to 14005 dt. 8.1.2010. Resolution taken by the Core Committee in the meeting dated 15.12.2009 was also put on the SHSB's website- [www.statehealthsocietybihar.org](http://www.statehealthsocietybihar.org) for information of the bidders.







The Core Committee meeting held on 29.1.2010 to verify and evaluate the documents/paper. During the meeting core committee members found that some reputed firms have not submitted the requisite papers/documents. Hence committee resolved that the reputed firms who have not submitted the requisite documents should be given again an opportunity to submit the requisite paper keeping in mind that these reputed firms must possess such documents. These reputed firm should be given again 10 days time to submit the papers and should be informed telephonically by SHSB. Accordingly, these firms were informed telephonically to submit the requisite papers/documents latest by 8.2.2010 i.e. before the next Core Committee meeting scheduled on 9.2.2010.




Companies which are technically qualified and physical site inspection and documents verification have never been carried out before and the firms whose site inspection and physical verification has been carried out three years ago i.e prior to drug tender round IV (year 2007) their site inspection and physical verification must have to carry out.


The firms whose site inspection and physical verification and documents verification have been carried out for Drug Tender Round-IV or V or VI i.e. within three years, their site inspection and physical verification not required.


As per the record available in the SHSB, during the Drug Tender Round-IV or V or VI, 16 (sixteen) companies (out of above 60 companies) have already been physically site inspected and their documents verified. Accordingly State Drug Controller, Bihar was requested vide letter no 14973 dt 04/3/2010 to send a two man team of (one Licencing Authority and one Drug Inspector) for physical verification and site inspection of rest 44 companies/firms which are never inspected before and three years before (before 2007)




**Resolution taken by the Core Committee in this meeting :-**


Inspection team were sent to above said 44 companies at their 48 manufacturing sites for physical site inspection and documents verification. The reports submitted by the inspecting team were reviewed by the core committee members except M/S Aditya Birla Chemicals (India) (Bihar Caustic & Chemicals Ltd) Garhwa Road, Rehla- 822124, Distt: Palamu, (Jharkhand), whose report has not been submitted by the inspecting team. Analysis of documents/ & papers of M/S Aditya Birla Chemicals (India) (Bihar Caustic & Chemicals Ltd) will be done in any next core committee meeting.


After detail evaluation and analysis of each and every report submitted by the inspecting team, the committee declared the following firms technically disqualified on the basis of the site inspection and physical verification report :



"There is no point of considering M/s Aurobindo Pharma either unit VI or III for making the rate contract by SHSB.





2. The committee was informed by SHSB that one batch of ASVS manufactured by VINS Bioproducts Limited 806, Essjay House, Road No.-3, Banjara Hills, Hyderabad has been declared as "Not of Standard Quality" and fails to neutralize Cobravenom by Central Research Institute, Kasauli. The committee was further also informed by SHSB that Erysin 125 ml Suspension of Maiden Pharmaceuticals Limited, Unit- 109, Plot No.-1, Vardhman Shopping Kunj, Rohit Kunj, Pitampura, Delhi- 110 034 and Doxycycline 100mg cap of Ind-Swift Limited, unit-I, plot no 23 sector II Parwano-173 220 (Head office- 781, Industrial Area, Phase II, Chandigarh -160 002) were also declared "Not of Standard Quality" by the Govt. Analyst after test and analysis. The committee considered the matter in the light of tender condition 'p' and recommended that in view of the tender condition, no further supply order should be given to the erring companies and should be blacklisted and barred from applying for any tender. In view of the above M/s VINS Bioproducts Limited Hyderabad, M/s Maiden Pharmaceuticals Limited Delhi and M/s Ind-Swift Limited, Chandigarh are declared technically disqualified by the Core Committee. Necessary actions for the same has already been initiated by State Drug Controller, Bihar, Patna.
3. During the evaluation and technical analysis of the report the committee observed that some of the firms have not submitted the original tender required documents to the inspecting team. The members were of the view the documents asked to be produced by the inspecting team must be shown at the time of their firm's site inspection. The issue was deliberated by the committee members and finally resolved that firms, who have not shown the original documents to the inspecting team, should be given an opportunity to produce the original documents before the committee constituted by the State Drug Controller, Bihar, Patna for verification. The State Drug Controller office will constitute a committee headed by State Drug Controller, Bihar, Patna consisting of the member of the inspecting team and Licencing Authority who have inspected the such firms as well as Licencing Authority and Drug Inspector deputed at SHSB. The committee will submit his report to SHSB indicating that whether the firm technically qualified or disqualified as per required documents produced before the committee. This report shall be treated as full and final report in this regard. State Drug Controller fixed 26<sup>th</sup> April 2010 the same.


Core Committee resolved that the SHSB will inform all such following seven firms to produce all the required documents positively on 26<sup>th</sup> April 2010 before the committee constituted by State Drug Controller Bihar office for verification. It was also resolved that if any firm fails to produce the required papers / documents or do not turn up on the fixed date and time before the committee for verification, then the firm will be treated as technically disqualified.


