

Minutes of the Technical Committee Meeting On Indelible Ink Marker Pens

Background: Indelible Ink Marker Pens are used during Pulse Polio Round to mark on the finger nail of the Immunized Children to see whether the child has been immunized or not. A tender notice was published for rate contracting of Indelible Ink Marker Pens in the Newspaper namely: Hindustan (Hindi, Bihar Edition), Dainik Jagaran (Hindi, Bihar Edition), Hindustan Times (Delhi Edition), Times of India (Mumbai & Pune Edition), Business Standard (Hyderabad & Bangalore Edition) on 07.03.2010. The eligibility criteria and tender details were also made available on SHSB web site: <http://www.statehealthsocietybihar.org>. Till the last date for submission of tender, total 2 tenders were received.

Meeting of Technical Committee was held on its pre scheduled date 31.03.2010 to open and evaluate the Technical Bid received from the following two bidders.







Technical Bids of the bidders were opened in the meeting and cover envelopes containing the technical bid as well as the bid itself was duly signed by the members and by the representative of a bidder Kores (India), Ltd. present in the meeting. Bidder of Luxor Writing Instruments Pvt. Ltd. was informed telephonically but they show inability to attend the meeting. Hence, technical bids were opened in the presence of members of technical committee & authorized representative of Kores (India), Ltd.

A Technical comparative chart was prepared in the meeting itself and was put up before the committee members for evaluation. And another important criteria of the quality test of the sample of Indelible Ink Marker Pens & to check the impression on minimum 500 to 600 children (submitted by the bidders) has been handed over to Dr. Hemant Shukla RTL- NPSP (WHO), Patna, According to tender specification the two major parts of quality test are as follows: -

It will be evaluated for 2 counts


- The Indelible Ink Marker Pen should be usable for impression on **minimum 500 to 600 children per pen** under Pulse Polio Immunization Programme.
- The impression put on the finger of children should last for at least 7 days from the day of marking.


On 10.04.2010 the test report of quality of Indelible Ink Marker Pen & the check of Impression on minimum 500 to 600 children per pen has been submitted by RTL- NPSP(WHO), Patna (which has been annexed as Annexure - I). In the said report only one Company/ Firm namely Kores(India) Ltd., New Delhi has been qualified technically.


According to Tender Specification of Indelible Ink Marker Pen it has been mentioned that the "Shelf life of the pen should not be less than ten months from the date of supply whereas **Luxor Writing Instruments Pvt. Ltd. 7, Okhla Industrial Estate , Phase - III, New Delhi-110020** has mentioned in his tender document that the Shelf life is 6 months from the date of manufacturing.


The committee also resolved that out of the total two bids only one Kores(India) Ltd. New Delhi, qualified technically. As per the approval of Finance Department in similar case, it is not a case of single tender. Hence in the light of Finance Department approval (relevant copy of order page from the file attached) the committee resolves to go ahead with the single qualifying bid of Kores (India) Ltd. and Financial Bid-Cover -B may be opened after getting approval of the concerned higher authority.

The committee resolved that the only one company/firm namely **Luxor Writing Instruments Pvt. Ltd. 7, Okhla Industrial Estate , Phase - III, New Delhi-110020** , who was not qualified technically should be uploaded on State Health Society, Bihar, website.




Status – Finalization of rate, contract for the financial year 2010-11.




Resolution Taken by the PAC in this meeting-


1. As decided in the earlier resolution, in the presence of the Committee members & Company representative the Financial Bid was duly signed by all the present members & Opened.
2. As per resolution in the earlier meeting the quoted rate which was found to be Rs. 14.90/- per piece (including of all taxes & transportation etc.), is less than 10% than last year quoted price.
3. Rates from other states i.e. West Bengal, Jharkhand, Karnataka, Tamilnadu, Maharastra, Pudducherry & Orissa was also compared with the new quoted rate and was found to be less.
4. Based on earlier resolutions as the rate was less than other states and the enhancement in price is less than 10% of last year quoted price, the Committee unanimously decided to approve the Kores (India) Ltd. price for Indelible Ink Marker Pen at the new rate (@Rs.14.90/- per pen) for this financial year 2010-11, for all the SIA rounds in the state.




