CORRIGENDUM OF EXPRESSION OF INTEREST

Notice for Expression of Interest to operationalise Basic Life Support Ambulance Services in all the districts of Bihar.

State Health Society, Bihar invites Expression of Interest (EoI) to operationalise and manage 504 Basic Life Support Ambulances (BLSA) in various districts of Bihar for providing reliable, trustworthy and quality emergency response service in the districts. The basic Life Support Ambulance with registration, insurance & inbuilt GPS will be provided by State Health Society, Bihar. The bidder will be expected to operate and manage the ambulances on 24x7 basis.

<u>Eligibility Criteria:</u> They must have capacity to maintain adequate inventory stock of medicines and the consumables. The bidder will be required to provide emergency medical technician trained in First Aid, Basic Life Support and Emergency Services Protocols and a driver on 24x7 basis. Experienced and registered organizations including NGOs fulfilling the following criteria are invited to submit EoI.

Technical Bid:

- i. Experience of running emergency response service/ambulances in at least one of the states of India through PPP. Testimonials of such experience should be enclosed with the EoI.
- ii. Should have at least 1 year experience of operating and managing Basic Life Support Systems Ambulances. Testimonials of such experiences and List of customers should be enclosed with Eol. Experience of longer duration in this field would be preferred.
- iii. Reputed NGOs/Organisations having sufficient experience and resources would be given priority.
- iv. Minimum Average Annual Turnover of Rs. 1 Crore during the last three financial years (2008-09, 2009-10 & 2010-11)
- v. Audited statement of account for the last three years (2008-09, 2009-10 & 2010-11).
- vi. Non-conviction certificate for the last three years submitting affidavit from Magistrate/Notary that they are not blacklisted by any Govt. Dept./Govt./ Ministry or that there is no pending case in any Court of Law.
- vii. Income Tax Return for year 2008-09, 2009-10 & 2010-11.
- viii. Demand draft of Rs. 10,000/- (refundable) in favour of State Health Society, Bihar.
- ix. Amount of performance guarantee will be decided at the time of signing of contract and will be valid for the period of one year. This may be renewed annually.

Financial Bid: The financial bid may be given in the following format:

<u>Opening date of Financial Bid</u>: Financial bids of the technically qualified bidders will be opened on 26.09.2011 at 3.00 PM at SHSB in the presence of the parties.
