Project Description

State Health Society Bihar is implementing the National Rural Health Mission (NRHM) to carry out necessary corrections in the basic health care delivery system. The Goal of the Mission is to improve the availability of and access to quality health care by people, especially for those residing in rural areas. As part of its overall mandate of ensuring accessibility to good quality health care in villages and also the goal of the programme is to provide training to the ASHAs. The training of all ASHAs for Modules 5, 6 & 7 has to be conducted in all 38 districts.

Role of Agency – 1. The State intends to select one or more agency for each District. The selected agency will conduct training programme in their allotted districts. Agencies/ NGOs will support as ASHA training site within the district with adequate training and infrastructural facilities, close access to a community, and linkage to a health facility, with an adequate case load of new born and children with illness. Agency having an active community presence and linkage but not the requisite infrastructural facilities, can also apply with ability to rent such training facilities on a long term basis. The caveat is that such training facilities (accommodation and training) should be close to the field operation site, and within easy access to the health facility which could be a block PHC or CHC depending on the case load of newborns and childhood illness.

- 2. Ability to manage good logistics /arrangement for residential training.
- 3. Monitoring and supportive supervision of ASHAs during /after the training & rolling out period.

<u>Minimum Eligibility Criteria: -</u> The intending should meet the following criteria to be eligible–

- (i) Experience of at least 5 years of working in Govt. Health Sector.
- (ii) Being registered for at least 5 years.
- (iii) Having registered branch offices in the preferred District.
- (iv) Experience of conducting training programme.
- (v) Having own infrastructure for conducting training which will be residential. A batch will consist of 35 participants Photographs of that premises should be attached.
- (vi) Having their own health trainers to conduct the training programme will be preferred. These trainers will be trained by Master Trainers at State Health Society/ State training sites.
- (vii) Annual turn over of Rs. 50 lacs or more during last three years.
- (viii) Access to community and health care facility.

Technical EOI Condition -

- A minimum average annual turnover of Rs. 50 Lacks in the last three consecutive financial years 2006-07, 2007-08 and 2008-09.

- PAN Card.
- Income Tax return Report for Assessment Year 2007-08, 2008-09 and 2009-10. A.C.A Certificate will not be accepted.
- Must not be black listed by any agency or pending case either Civil or Criminal against them.
- Earnest Money Bidders will be required to deposit Rs 20000 /-(Refundable) in the form of Demand Draft favoring "State Health Society, Bihar" as EMD.
- Bidders will be required to submit documents regarding their experience and know how in training sector, along with full specification printed on A4 size paper.
