Background: Indelible Ink Marker Pens are used during Pulse Polio Rounds to mark on the finger nail of the Immunized Children to see whether the child has been immunized or not. A tender notice was published for rate contracting of Indelible Ink Marker Pens in the following Newspaper namely: Dainik Jagaran (Bihar Edition), Hindustan Times (All India Edition), Times of India (Patna Edition) And The Hindu (Chennai Edition) on 19.02.2011. The eligibility criteria and tender details were also made available on the SHSB web site: http://www.statehealthsocietybihar.org. Till the deadline for submission of tender, a total of 3 tenders were received.
