EXPRESSION OF INTEREST

Notice for Expression of Interest to supply portable Fogging machines.

State Health Society, Bihar invites Expression of interest directly from reputed manufacturer or direct importers, who have minimum Annual Turn of more than Rupees 5 Crores in each of the three financial years i.e. 2008-09, 2009-10 and 2010-11 to demonstrate and supply **Portable Fogging machines** (about two hundred in number). These fogging machines should be useful for fogging the whole area, which is to be disinfected against flying insects like mosquitoes, flies etc. The interested manufacturer or importer, here-in-after will be called as “**agencies**“ will be expected to supply and demonstrate the required portable fogging machines in the State of Bihar.

Project Objective:-

Cases of Patients suffering from Japanese Encephalitis/ Acute Encephalitis syndrome, Dengue, Chickenguinea, Malaria are being reported from various districts of the state. Intensive fogging of insecticides are required to be carried out to disinfect the concerned area for proper prevention and control of these diseases.

The fogging machines will also be useful in prevention & control of Malaria & kala-a-zar, which is very common in most of the districts of the state.

Minimum Eligibility Criteria:-

1. EOI is invited only from Manufacturers/Company/Firms who are either Manufacturer of the required machine, at their own manufacturing unit or are the authorized importer of the required machine in India. Agencies which have been blacklisted by Central Govt./ Govt. of Bihar and/or by SHSB and the agencies which have been de-registered , debarred by Govt. of Bihar and/ or by SHSB are barred from participating in this EOI.
2. Indian manufacturer must have required industrial Licence alongwith BIS or equivalent Certificates. Foreign manufacturers must have required permission for marketing of these machines in India.
3. Annual turnover of the company should be of minimum Rs 5 Crores in each of the last three financial year i.e. 2008-09, 2009-10 & 2010-11.
4. The agencies shall provide the detail specifications of machine.
5. Detail Literatures, Booklets, Brochures etc. in connection with required machine should be accompanied with the EOI.
6. The agencies will have to demonstrate the function & working style of the required machine.
7. Certificate of Sales Tax /VAT registration.
8. Photocopy of PAN card.
9. Audited financial statement of last three financial years i.e. 2008-09, 2009-10 & 2010-11.
10. Duration of warranty being provided by the agencies along with period of CMC.
11. Performance Certificate issued by the Previous established purchaser.

Submission Requirement:-

Interested Manufacturers, or importer, having experience in the field of supply of **portable fogging machines** willing to undertake the above task may submit their **expression of interest** along with their brief

proposal, summary of their organization profile, Experience details, financial statements, etc. in a sealed envelop subscribing “EOI to supply and demonstrate portable fogging machines. This envelope shall also contain all necessary documents required in support of minimum eligibility criteria mentioned above. All such documents to be submitted by the Agencies must be signed by the authorized signatory of the firm. The EOI may be sent to the address stated below by registered post/speed post only latest by 31.5.2012.

The EOI and the documents attached with it shall be used to short list the agencies. The qualified and short listed agencies shall be asked to make demonstration and to arrange presentation of required portable fogging machines before the members of the expert committee, constituted by SHSB for this very purpose without any cost and commitment at Patna.

On the recommendation of the above said Expert committee SHSB shall approve the specification of required portable fogging machine for procurement, for which EOI has been submitted. Accordingly financial bids will be invited as per the approved specifications from the short listed applicants of EOI.

The SHSB reserves the right without any obligation and liabilities, to accept or reject any application of EOI or to annual the process at any time, without assigning any reason thereof.
