Sealed Tenders are invited from the Manufactures/ authorized dealers for supply of equipments fabricated Mobile Medical Units as per the details given in the tender documents.

The details of the tender documents are available on the website i.e. www.statehealthsocietybihar.org, from which Tender document may be downloaded.

The tender shall be submitted in a single big size envelope containing three envelopes one for “**Technical Bid**” second for “**Financial Bid, in original**” and third for “**Financial Bid in Duplicate**” duly sealed and super-scribed as tender for “**Supply of Equipments fabricated MMUs**” addressed to the **Executive Director, State Health Society, Bihar, Pariwar Kalyan Bhawan, Sheikhpura, Patna-800 014** and should reach the office by or before **15.11.2013 by 3:00 p.m.** The sealed tender(s) should be sent only through Registered/Speed Post only. Conditional tender or tenders received after the due time and date shall not be entertained in any circumstances. The postal delay shall not be the responsibility of the society. The tender(s) will be opened in the SHSB’s Conference Hall by the duly constituted committee **on 15.11.2013 by 4:00 p.m.** in presence of any intending supplier or his/her authorized representative who may wish to be present at the designated time and place. If for any reason the same could not be opened on the appointed day, the next fixed date for opening shall be uploaded on the same website. SHSB reserves the right to accept or reject any tender or any part thereof without assigning any reasons. The rates should be quoted against each item of the tender **in both words and figures without cutting & tampering**, but for **deciding price, the compact value of the equipments as a whole (not item wise rate) and quality** thereof would be taken in to account. **Transparent tape should also be applied on rates quoted.**

TENDER DOCUMENT

For Supply of Equipments Fabricated Mobile Medical Units (MMUs)

Sealed Tenders are invited from the Manufactures / authorized dealers for the supply of equipments fabricated MMUs. The tender shall be submitted in a single big size envelope containing three envelopes one for "Technical Bid" second for "Financial Bid, in original" and third for "Financial Bid in Duplicate" duly sealed and super-scribed as tender for "Supply of Equipments fabricated MMUs" addressed to the Executive Director, State Health Society, Bihar, Sheikhpura, Patna – 800 014 and should reach the Office by or before **15.11.2013 by 3.00 p.m.** The sealed tender(s) should be sent only through Courier/ Registered/Speed Post. Conditional tender or tenders received after the said time and date shall not be entertained in any circumstances. The postal delay shall not be the responsibility of the society. The tender(s) will be opened in the SHSB's Conference Hall by the duly constituted committee on **15.11.2013 by 4:00 p.m.** in presence of any intending supplier or his/her authorized representative who may wish to be present at the designated time and place. If for any reason the same could not be opened on the appointed day, the next fixed date of opening shall be uploaded on the same website. SHSB reserves the right to accept or reject any tender or any part of the tender without assigning any reasons. **Technically qualified bidder** shall be invited to attend the meeting called for opening of the "finance bid" and intimated accordingly. The rates should be quoted against each item of the tender **in both words and figures without cutting & tampering**, but for **deciding price, the compact value of the equipments as a whole (not item wise rate) and quality** thereof would be taken in to account. **Transparent tape should also be applied on rates quoted.**

A Pre-Bid discussion with the intending bidders in respect to the above said tender shall be held on **29.10. 2013 at 1:00 pm in the conference Hall of State Health Society.**

Tender has to be submitted in two parts:

- I. The first part i.e. "technical bid" constituting minimum eligibility criteria is to contain self attested photocopies of the documents/ papers as follows:
 1. The intending bidders shall have to deposit an amount of Rs. 1000000 (Rs. Ten Lacs Only) as token **refundable** Earnest Money in the shape of Bank draft/Bankers cheque/Fixed deposit from any Nationalized/commercial Bank Payable to State Health Society, Bihar, Patna.
 2. The bidders should be a manufacturer/fabricator or its authorized agent/dealer with **some specific experience of supplying equipments fitted**/fabricated Mobile Medical Unit with support vehicles.
 3. The bidders should have a minimum **annual turnover of Rs. 10 Crores** in each of the three A/y. 2011-12, 2012-13 & 2013-14 duly supported by Annual Audit Report containing balance sheet for each of the year certified by the Chartered Accountant. (Merely Turnover Certificate from C.A will not suffice). In case of authorized dealer, the turnover of the manufacturer will be considered.
 4. The bidders must have VAT/CST Tin registration along with return for F.Y. 2009-10, 2010-11 & 2011-12.
 5. The bidders must indicate in their bid the original manufacturing source for the various equipments to be fabricated in the MMUs, and must enclose necessary documents to this effect including **product brochures** along with **quality standard certification** and if possible **Price catalogue** also.
 6. Copies of PAN, and Income Tax Returns for A/y 2011-12, 2012-13 & 2013-14 are to be enclosed.
 7. The equipments must be of standard quality with all requisite parameters supported by quality certifications, in addition to the specifications of the lowest prices schedule.
 8. Schematic Drawings/**Layout**/Design of the fabrication of the MMU with essential equipments specifications & literature to be submitted along with the tender as per Annexure-I. However, at the time of approval of tender PAC (Project Appraisal Committee) can ask for demonstration of medical/surgical equipments as and when required.
 9. The bidder shall furnish a notarized affidavit of non-blacklisting (by any Govt./ Private institution) certificate containing a declaration to the effect of non-pendency of vigilance/CBI case against it.
 10. Power of Attorney/ resolution of the board as regards authorized signatory of documents.

Note (Grounds of Outright Rejection of Bid) :-

- (i) The EMD (Earnest Money Deposit) and the **self attested copies of all the required documents** are mandatorily to be furnished along with the bid.
- (ii) It should be ensured that **every page of tender document is duly marked and signed with seal without cuttings/over writings/fluiding. If at all, cutting has become inevitable, it should be duly signed by the authorized signatory.**
- (iii) In no case, any opportunity shall be provided to any bidder to correct the bid or submit documents not originally submitted.

II. The second part i.e. Financial Bid' is to contain:

1. **Price-Bid**" (Financial bid) properly sealed separately along with duplicate, superscribed as **Tender for MMU** shall contain details of the **Itemized rate quoted Printed Sheet (not hand written)** inclusive of all taxes/duties/ levies and transportation charges etc **detailing each component of the price separately.**
2. Rate of each items/equipment is to be **quoted with complete details of specification/features, make (Name of the Manufacturer) and Model.**
3. Rates are **FOR (Free on Rail) destination.**
4. Cutting, fluiding and overwriting, even with signature of the bidder is not admissible.
5. Each page of 'Financial Bid' is duly marked, signed, and sealed.

Note:

- (a) **Non-adherence to these stipulated conditions may lead to non-consideration of the bid.**
- (b) However, **while deciding the price the compact value of the Mobile Medical Unit as a whole (not item wise rate) would be taken in to account.**

TERMS & CONDITIONS OF TENDER

BIDDERS SHOULD READ THESE CONDITIONS CAREFULLY AND FOLLOW THESE PARAMETERS STRICTLY BEFORE SUBMITTING THEIR TENDERS. IN CASE A BIDDER HAS ANY DOUBTS/RESERVATIONS REGARDING THE TERMS & CONDITIONS AND SPECIFICATIONS THEREIN, THE SAME CAN BE RAISED BEFORE THE EXECUTIVE DIRECTOR, STATE HEALTH SOCIETY, BIHAR ON OR BEFORE THE PRE-BID MEETING FOR SEEKING CLARIFICATIONS TO AVOID ANY FURTHER DISAGREEMENTS AS SUCH.

THE INTENDING BIDDERS MAY ALSO SUBMIT THEIR COMPLETE PROPOSAL FOR SUPPLY OF EQUIPMENTS FITTED MOBILE MEDICAL UNITS SUBJECT TO UNDERMENTIONED TERMS AND CONDITIONS.

1. 14 Vehicle/Chassis shall have to be supplied or made available under the terms and conditions stipulated in the rate contract with the following minimum specifications:
 - (i) Engine 4 cylinder engine developing 90 PS @2200 to 3200 rpm and generating a torque of 250 ~ 300 Nm@/300 – 2000 rpm
 - (ii) Gear box Synchronesh on all five forward gears
 - (iii) Rear Axle Ratios 6.587 : 1
 - (iv) Brake (service) Air Break/ Vacuum assisted hydraulic dual circuit with automatic
 - (v) No. of Wheels & Tyres Front - 2, Rear -4, Spare – 1
 - (vi) Tyre Size 7.50x16/8.25 – 16PR
 - (vii) Wheelbase 3800 - 4050 mm
 - (viii) Max. Gradeability 24%
 - (ix) MAX. GVW 6400 to 8800 Kgs
 - (x) Body Aerodynamic, windows with toughened glass, Sheet metal anti corrosive body, aluminum flooring, rear door should be of two pieces with looking arrangement
 - (xi) Wheel :- 6+1
 - (xii) Electric System 12 volt battery 70 AH capacity enough for vehicle lightning and cabin equipment to work
 - (xiii) Bharat Stage III
2. The bidders shall have to furnish details of quality stipulations of equipments forming part of Annexure I.
3. However, if the bidder has any authorized registered dealer/agent in the state of Bihar, no CST will be payable. If the bidder does not have any authorized dealer / agent in the state of Bihar, then CST may be payable instead of VAT.

4. The bidder will have to ensure free demonstration of the equipments fitted MMU at a pre-determined place after award of tender within 45 days of the placement of work-order to satisfy its members for technical acceptability as per the tender specifications. No compromise will be acceptable as regards to the quality, durability, & guarantee of the fabrication and equipments.
5. After submission of tenders, at first, technical bids will be opened by a duly constituted Technical Bid committee on the due date of opening of the tender and subjected to technical evaluation thereafter. Only those bidders found successful on technical evaluation will be considered for opening, and evaluation of financial bids by the PAC.
6. The purchaser will award the contract to the successful bidder will be dependent primarily on the basis of lowest bidder subject to previous experience of supplying similar vehicles with documentary proof.
7. The bidder will submit an undertaking on non-judicial stamp paper worth of Rs. 100/-
 - (i) For imparting training on the fitted equipments to the 'Emergency Medical Technicians', who will be deployed in these Mobile Medical Units on dates and time fixed by SHSB.
 - (ii) The bidder will go for mutually agreed AMC for five years after the expiry of warranty period of two years.
8. In case, any bidder is found guilty of forging/tampering any document / certificate, the firm is likely to face legal action against them under laws of the land including forfeiture of their earnest money.
9. The rates quoted should be inclusive of all taxes including entry tax, duties, and other charges if any.
10. Details of documents enclosed with the tender forms should be mentioned in proper Index serial wise (as per tender document) duly flagged on the front page of the tender.
11. No conditional tender shall be accepted. The PAC reserves right to accept or reject any tender/ quotation without assigning any reasons thereof.
12. The approved firm/bidder shall be bound to deliver the fabricated Mobile Medical Units within 90 days from the award of contract or acceptance of contract.
13. If the delivery is not effected on due date, SHSB will have the right to impose penalty of the total cost of the supply order @ 2% for each week subject to the maximum of 15%.
14. The successful bidder shall be responsible for execution of the supplies strictly in accordance with the contract in full and shall not in any case assign or sublet any part thereof. Deviation, if any can lead to forfeiture of Earnest money or even black listing.
15. In case the bidder fails to demonstrate the equipment fabricated Mobile Medical Unit before the PAC within the allocated timeframe, or fails to supply the Fabricated MMU within the delivery period, the State Health Society reserves the right to cancel the placed order, and forfeit the earnest money. The action of forfeiture of earnest money may well be taken in the following cases as well:
 - a) When bidder withdraws or modifies the offer after opening of technical bids.
 - b) When bidder does not execute the agreement prescribed within the specified time.
16. The successful bidder is bound to supply the same on the rates once quoted and approved by State Health Society, Bihar.
17. The approved supplier shall carefully examine the conditions, specifications, size, make, and catalogue/drawings etc. of the equipments to be supplied. In case of any doubts, he/she shall contact the concerned SPO and get clarifications.
18. All the terms and conditions of tender notice shall form part of the supply order/agreement even if they are not explicitly mentioned therein.
19. The successful bidder shall have to abide by the standard terms and conditions as laid down in the General Financial Rules, 2005 of the state and Indian Contract Act, 1872, and those of the contract/ agreement to be executed.
20. The sample vehicles should be offered for inspection within 45 days from the date of confirmed order, and balance vehicles should be supplied within 45 days from the date of sample vehicles clearance.
21. The successful bidder will have to furnish a bank guarantee of @ 10% of the amount of the Mobile Medical Unit value as performance guarantee valid for a period of 60 days more than that of the period of agreement.
22. After clearance of sample vehicle, the manufacture/ dealer will confirm the supply to be exactly as per the sample vehicle cleared by the department. There should be no action / deviation after approval of sample.

23. All the equipments supplied should be of the best quality, specification, and trademark, and in accordance with the approved standard, catalogue, and samples. Any change in the fitted equipments without approval is liable to be replaced by the supplier at its own cost.
24. The bidders shall be responsible for the proper delivery of fabricated MMU. In the event of any loss, damage/breakage, the bidders shall be liable to make good such loss/damage found at the checking/inspection/verification of the MMU by the supplier, no extra cost on such account should be admissible.
25. In case of any dispute/ difference or doubts between the SHSB and the approved suppliers arises, the orders of the Chief Executive Officer, SHSB-cum-Health Secretary shall be final and binding.
26. 30% payment towards the cost of Mobile Medical Unit may be made in advance as against Bank Guarantee along with order and balance 70% of Mobile Medical Unit cost after receipt of vehicles.
27. PAC holds the right to accept or negotiate as regard the reasonability of rates subject to the approval of Executive Director, SHSB.
28. Logo of National Mobile Medical Unit as per GoI guidelines and purposes of Mobile Medical Unit has to be superscribed on the outer body of MMU in consultation with State Programme Officer.
29. Any claims, question or objections / grievances in respect of this tender should reach prior to the Pre-bid meeting after which no claims/ objections will be considered.
30. Legal proceedings that may arise at any time shall be subject to the jurisdiction of Patna Courts only.
31. The bidders would in no case be allowed to correct or replace or vary the document/s once filed along with the bid.
32. An agreement to that effect will be signed with the successful bidder after final short listing and award of contract.
33. State Health Society reserves its right to accept or reject any or all bid/s, and vary any terms/ matter of the bid or annul the bidding process itself at any time without assigning any reason thereof.
