
Agenda – Rate Contract of Indelible Ink Marker Pen

Status – Finalization of rate contract for the financial year 2013-14.


Background : Indelible Ink Marker Pens are used during Pulse Polio, Immunization Programme and other Campaigns to mark on the finger nail of the Immunized Children to see whether the child has been immunized or not. A tender notice was published for rate contracting of Indelible Ink Marker Pens in the Newspaper namely: Hindustan Hindi (All Bihar Edition) and Times of India (All India Edition). Till the last date for submission of tender, total three tenders were received.


Opening of Technical Bids and their Evaluation by Core Committee and PAC



Out of 3 (three) bids received, only One Company/Firm namely **Kores(India) Ltd., Patna** met all the technical specifications listed in the tender document.


Resolution Taken by the PAC in this meeting-


