## TENDER BID

Tender Bid is invited from reputed NGOs/Agency/Individual/Firms for setting up of generic drug shops through Public Private Partnership (PPP) in Medical Collage Hospitals, District Hospitals, Sub divisional Hospitals & Primary Health Centers of Bihar. Other than existing generic drug shops.

### Project Scope:-

- (i) 4 Generic Drug Shops in each of the 6 Govt. Medical College Hospitals. (annexure-I)
- (ii) 3 Generic Drug Shops in each District Hospitals & Sub Divisional Hospital. (annexure-II)
- (iii) 2 Generic Drug Shops in all PHCs. (annexure-III)

### Project Condition:-

The State government will only provide 300 sq. feet (approx) of empty space in Medical College Hospitals, 200 sq. feet of empty space in District & Sub Divisional Hospitals, 150 sq. feet of empty space in PHCs. Successful bidders are required to put up a prefabricated structure in the provided empty space to operate the generic drug shop on their own cost. In some places generic drug shops have been built by the State. They will be made available to the successful highest bidders. Others will have to construct generic drug shop of prefabricated material on their own cost.

The agency has to ensure & stock only generic drugs other than mentioned in essential drug list of Health Department (Annexure-iv available on official website ~~SHSB- [www.shsbihar.org](http://www.shsbihar.org)~~) The agency is also required to stock generic drugs which are used in life style diseases for life long uses eg. Diabetes . Hypertension. Cancer. Hypercholesteremia. Thyroidism Epilepsy etc. The agency may however stock minor surgical instruments- Cotton Bandage. Thermometer etc. But in no circumstance the agency shall be allowed to stock branded drugs. Procurement of all generic drugs including minor surgical equipments should be necessarily from GMP companies having an average turnover of Rs. 25 Crores or above and WHO certified. Minimum expiry period of the products should not be less than 1½ years from the date on which the shop receives the product provided if the shelf life of the drug is 1½ years only. the above condition shall be reduced to 1 year. The selected agency may also open a counter for sale of power spectacles

**Quality Control-** To ensure the quality of the drugs, Drug Inspectors will draw samples of the drugs randomly for the purpose of Test or Analysis. If after the test and analysis, the drawn sample is declared to be not of Standard Quality then suitable and proper action will be taken as per the provision of drugs and cosmetics Act, 1940 and Rules 1945 and the entire batch will be taken back by the supplier at supplier's cost and the agency will not be responsible for any damage during this period.

The responsibility of getting proper drug license from the competent authorities will lie upon the successful bidder.

Rates (to be charged from the users) shall be on market competitive rates on generic drugs. This condition will also apply on items other than drugs.

The Generic Drug Store should be operational 24 hours 7 days in a week.

Successful bidder must fulfill all the requirements as laid down in Drugs and Cosmetic Act and Rules.

**Project Time Frame :**

The project would be initially for three (3) years depending upon satisfactory performance further extension will be considered.

**Project Option :**

- (i) Any agency may offer bids for setting up of more than one shop but in not same premises.
- (ii) Any agency shall be awarded a maximum of one generic shop in Medical Colleges.
- (iii) Any agency shall be awarded any number of generic drug shops in other Hospitals in the District.

**Minimum Eligibility Criteria :-**

1. The intending body should have a minimum average annual turnover of Rs. 30 lacs for District Hospitals and 75 lacs for Medical Colleges or above in the last three years & 15 lacs in case of PHCs.
2. A market standing of minimum 3 years in the area. With valid drug licence.
3. Agency to produce Sales Tax Registration.
4. Must have qualified human resource for the task like pharmacist etc.
5. Must not be black listed by any agency or pending case either Civil or Criminal against them.
6. Earnest Money : Demand Draft of Rs. 30,000/- (refundable) for each District Hospital and 50,000/- (refundable) for each Medical College Hospital Rs 20,000 (refundable) for each PHC in favour of District Health Society, of the Concerned district.
7. The successful agency is required to set up shop in a maximum period of 3 months.
8. Pan card & Income Tax return

**Please Note :** In case the agency quoting the highest bid is unable to provide the services, the earnest money deposited by the agency shall be forfeited.

**Submission Requirements:** Interested Agency/ Firms/ Companies/ Individuals wishing to undertake the above task on behalf of the Local Rogi Kalyan Samiti submit in large sealed envelopes marked "Tender bid for Setting Up Generic Drug Shop through Public Private Partnership (PPP) in Medical College Hospitals, District Hospitals, Sub-divisional Hospitals & Primary Health Centre" That envelop will contain both Technical & Financial bids in separate sealed envelopes.

The bid document will be opened in presence of bidders who wish to be present on fixed prior announced date.

**The Technical Bid** should include the following :-

- (i) Capability Statement in not more than two A4 pages.
- (ii) Background of the firm organization with relevant experience in not more than two A4 pages.
- (iii) Summary of personnel/staff proposed for shop.
- (iv) Annual turnover with details and proper annual audit report for last 3 years.
- (v) Demand Draft of Rs. 30,000/- (refundable) for each District Hospital for which bid is submitted and 50,000/- (refundable) for each Medical College & Rs. 20,000/- only in favour of Local Rogi Kalyan Samiti of the concerned institution.

**Evaluation of Technical Bid:** The bidder needs to satisfy the Minimum Eligibility Criteria to be considered technically qualified.

**Besides the above the following documents should also be submitted:-**

- (i) Sales Tax Registration.
- (ii) Income tax return for last 3 years.
- (iii) VAT/ CST registration certificate
- (iv) Non-conviction certificate for the last three years submitting affidavit from Magistrate that they are not blacklisted by any Govt. Dept./Govt./ Ministry or that there is no pending case in any Court of Law.
- (v) Institution preference

**Financial Bid :-** Financial Bid should be as such.

1. The successful bidders will either be provided constructed generic medicine shop or they will be required to put up prefabricated structure in the provided space as mentioned in project condition.
2. The successful bidders will be required to pay the monthly rent of the space to the local Rogi Kalyan Samiti. After award of the tender they are required to report & operate under the guidance of local Rogi Kalyan Samiti.
3. The monthly rent of the space will be decided by the local Sub divisional Magistrate.
4. If there are more than one successful bidder, the final allotment will lie upon the bidder who may offer maximum rebate to the customer.
5. For rent fixation onus will lie upon the successful bidder.
6. The construction design of the shop will be decided by the local Rogi Kalyan Samiti.


