पुर्ननिविदा सूचना

(वातानुकूलित Mobile IUCD Van व Van के Fabricated सहित दर निर्धारण हेतु)

विभिन्न दैनिक समाचार पत्रों में पी0आर0 संख्या 10253(नि.नि.) 13—14 दिनांक 31.12.2013 तथा पी0आर0 संख्या 12358 (नि.नि.) 13—14 दिनांक 18.01.2014 के माध्यम से वातानुकूलित Mobile IUCD Van व Van के Fabricated सिंहत दर निर्धारण हेतु निविदा आमंत्रित की गई थी। चूंकि इस निविदा में मात्र एक ही बिड प्राप्त हुआ। अतः इसे रदद करने का निणर्य लिया गया है।

पुनः प्रतिष्ठित कम्पनी / प्राधिकृत विक्रेता / एजेंसियों से वातानुकूलित Mobile IUCD Van व Van के Fabricated सिहत दर निर्धारण हेतु मुहरबंद लिफाफे में पुर्निनिविदा आमंत्रित की जाती है। इस आदेश का निष्पादन बिना अविध विस्तार के निर्धारित समयसीमा के अंदर किया जाना है, अतः केवल गंभीर एवं समर्थ एजेंसी ही बिड में शामिल हों। निविदा में वर्णित सामग्री की आपूर्ति राज्य स्वास्थ्य समिति, बिहार के कार्यालय तक की जानी है।

इस निविदा संबंधित विस्तृत जानकारी यथा मात्रा एवं आपूर्ति, पात्रता मानदण्ड, आपूर्ति की अवधि एवं शर्ते इत्यादि अन्य संबंधित जानकारी राज्य स्वास्थ्य समिति, बिहार के वेबसाईट <u>www.statehealthsocietybihar.org</u> पर उपलब्ध है।

एक बड़े लिफाफे के अंदर (वित्तीय एवं तकनीकी निविदा हेतु) दो अलग—अलग लिफाफे डालकर बड़े लिफाफे के ऊपर " Supply of fabricated Mobile IUCD Van " अवश्य अंकित होनी चाहिए।

- 1) तकनीकि निविदा वाले लिफाफे पर "तकनीकी बिड" एवं
- 2) वित्तीय निविदा वाले लिफाफे पर "वित्तीय बिड" लिफाफे के उपर अवश्य अंकित होनी चाहिए। अग्रधन राशि के रूप में ₹2,64,000 / का डिमाण्ड ड्राफ्ट जो किसी अनुसूचित (Scheduled) बैंक से निर्गत हो एवं राज्य स्वास्थ्य समिति, बिहार, पटना के नाम से देय एवं पटना में भुगतेय हो (State Health Society, Bihar and payable at Patna), तकनीकी बिड के साथ अवश्य संलग्न होना चाहिए।

RE-TENDER NOTICE

For Supply of equipments fabricated air conditioned Mobile IUCD Van

A Tender was invited through advertisement in various news paper vide PR No. 10253(नि.नि.) 13—14 Dated: 31.12.2013 and PR No. 12358 (नि.नि.) 13—14 Date: 18.01.2014 for finalizing the price of Air conditioned Mobile IUCD Van along with fabrication. Since only one tender was received hence it has been decided to cancel the tender.

Fresh bids tenders are invited to finalize the rate of Air conditioned Mobile IUCD van along with fabrication in sealed envelopes from the Reputed Companies/Authorized Dealers/Agencies. This order is to be followed within any extension of time limit hence only truly interested and competent agencies should participate in the bid. The items mentioned in the bid are to be supplied to the Office of State Health Society at Patna, Bihar.

The tender shall be submitted in a single big size sealed envelope super-scribed "Supply of fabricated Mobile IUCD Van". This envelope must contain two sealed envelops one with "Technical Bid" and the second with "Financial Bid" only.

The tender documents must reach the office of the Executive Director, State Health Society-Bihar, Parivar Kalyan Bhavan, Sheikhpura, Patna – 800 014 (Bihar) by time and date stipulated below. The sealed tender(s) should be sent through Registered/Speed Post only. Tenders received after due date shall not be entertained under any circumstances. Tenders received late as a result of postal delay will not be the responsibility of the society. Firms/Representative of firms may be present at the time of opening of the tenders.

The intending bidders shall have to deposit an amount of Rs.2,64,000 (Rs. Two Lacs Sixty four Thousand Only) as refundable Earnest Money in the shape of Bank draft from a scheduled Bank and Payable to State Health Society, Bihar, Patna. Tenders without the earnest money will be rejected.

RETENDER NOTICE

For Supplying Fabricated air conditioned Mobile IUCD Van:

Sealed Tenders are invited from the Manufactures / authorized dealers for the supply of fabricated Mobile IUCD Van. All the vehicles have to be supplied to the State Health Society Office at Patna, Bihar.

The tender shall be submitted in a single big size sealed envelope super-scribed "Supply of fabricated Mobile IUCD Van". This envelope must contain two sealed envelops one with "Technical Bid" second with only "Financial Bid".

The tender documents must reach the office of the Executive Director, State Health Society-Bihar, Parivar Kalyan Bhavan, Sheikhpura, Patna – 800 014 (Bihar) by time and date stipulated below. The sealed tender(s) should be sent through Registered/Speed Post only. Tenders received after due date shall not be entertained under any circumstances. Tenders received late as a result of postal delay will not be the responsibility of the society. Firms/Representative of firms may be present at the time of opening of the tenders.

Important dates/ deadlines regarding the tender:

- Pre-bid meeting: 03-03-2014 at 11 AM (In State Health Society Office)
- Last date of receipt of the tender: In State Health Society Office the tender will be accepted only via registered/speed post up to 13-03-2014 till 3:00 PM or before.

In addition to above a **tender box** would also be available in Family Planning Cell at State Health Society, Bihar office from 10:00 AM to 3:00 PM in which the tender may be dropped.

 Opening of technical bid of the tender: 13-03-2014 at 4 PM (In State Health Society Office)

If the day on which the opening of tender is scheduled is declared a holiday, then the tender will be opened on the next working day at 4 PM.

Financial bid of only technically qualified bidders will be opened. The Technically successful bidders would be intimated in time and their representatives may be present at the time of opening of "Financial bid".

The following documents countersigned and self-attested by an authorized representative of the agency must be submitted with the "Technical Bid". It should be ensured that every page of tender document is duly marked and signed with seal of the agency and without cuttings/over writings/fluiding. If at all, cutting has become inevitable, it should be duly signed by the authorized signatory. Opportunity shall not be provided to any bidder to correct the bid or submit documents not submitted along with the tender documents. The tenders are liable to be rejected if any of the documents mentioned below are not attached in technical bid.

- The intending bidders shall have to deposit an amount of Rs.2,64,000 (Rs. Two Lacs Sixty four Thousand Only) as refundable Earnest Money in the shape of Bank draft from a scheduled Bank and Payable to State Health Society, Bihar, Patna. Tenders without the earnest money will be rejected.
- 2. The bidders should be a manufacturer of the vans or authorized dealer of the agency.
- 3. The bidders should have a minimum annual turnover of Rs. 5 Crores during last three financial year i.e 2010-11. 2011-12 and 2012-13, duly supported by Annual Audit Report containing

balance sheet for each of the year certified by the Charted Accountant. (Turnover Certificate from C.A will not be considered)

In case of authorized dealer, the turnover of the manufacturer will be considered.

- 4. The bidders must have VAT/CST Tin registration along with record of return for last three financial years.
- 5. The bidders must indicate in their bid the name of the original manufacturing source for materials to be for the purpose of fabrication of the Mobile IUCD Vans. The agencies are required to enclose necessary documents to this effect including product brochures along with quality standard certification and if possible Price catalogue also.
- 6. Copy of PAN card issued in the name of agency or proprietor in case of proprietary firm.
- 7. Copies of Income Tax Returns for last three Assessment year viz. 2011-12, 2012-13 & 2013-14 have to be enclosed.
- 7. The equipments must be of standard quality with all requisite parameters supported by quality certifications, in addition to the specifications of the lowest prices schedule.
- 8. Schematic Drawings/Layout/Design of the fabrication of the Mobile IUCD Van with essential materials specifications & literature to be submitted along with the tender as per Annexure-I.
- 9. Documentary proof of having supplied vehicles to government/semi-government/ government undertakings needs to be submitted along with.
- 9. The bidder should not be blacklisted presently by any Government/Semi government/ government undertaking. There should be no vigilance/ CBI case pending against the bidder. A certificate to these effects has to be provided in original along with the "Technical bid"
- 10. Power of Attorney/ resolution of the board as regards authorized signatory of documents.

II. Financial Bid must contain:

- 1. The envelope must be superscribed as "Financial bid for Mobile IUCD Van"
- 2. Financial bid, should be properly sealed
- 3. Financial bid shall contain printed (not hand written) details of the rates quoted item wise.
- 4. The rates should be inclusive of all taxes/duties/ levies and transportation charges etc detailing each component of the price separately.
- 5. Rate of each items/equipment is to be quoted with complete details of specification/features, make (Name of the Manufacturer) and Model.
- 3. Rates should be FOR (Free on Rail) destination.
- 5. Each page of "Financial Bid" should be duly marked, signed, and sealed.
- 6. The rates should be quoted against each item both in words and figures without cutting & tampering. Cutting, fluiding and overwriting, even with signature of the bidder is not admissible
- 7. Transparent tape should be applied on rates quoted.

Note:

- (a) Non-adherence to these stipulated conditions may lead to non-consideration of the bid.
- (b) However, while deciding the price the compact value of the Mobile IUCD Van as a whole (not item wise rate) would be taken in to account.

TERMS & CONDITIONS OF TENDER

Bidders should read terms & conditions carefully and follow the parameters strictly before submitting their tenders. In case a bidder has any doubts/reservations regarding the terms & conditions and specifications, the same can be raised before the Executive Director, State Health Society, Bihar on or before the pre-bid meeting for seeking clarifications to avoid any confusion. The intending bidders may also submit their

complete proposal for supply of fabricated mobile IUCD Van subject to under mentioned terms and conditions.

- 1. Twelve (12) Vehicle/Chasis shall have to be supplied or made available under the terms and conditions stipulated in the rate contract with the following approximate specifications:
 - (i) Mobile IUCD Van with at least two years' warranty
 - (ii) Seating 9+D
 - (iii) Engine 4 cylinder engine developing 90 PS @3000-3500 rpm and generating a torque of 220 250 Nm@/1500 2000 rpm
 - (iv) Gear box Synchromesh on five forward gears and 1 back.
 - (v) Rear Axle Ratios 6.587:1
 - (vi) Brake / Disk Brake/Drum Brake
 - (vii) No. of Wheels & Tyres Front 2, Rear -2, Spare 1
 - (viii) Tyre Size min.R 15
 - (ix) Wheelbase 3200-3500
 - (x) Ground clearance min 180 mm (since Vehicle has to move to remote Villages).
 - (xi) MAX. GVW 3200-4000
 - (xii) Body Aerodynamic, windows with toughened glass, Sheet metal anti corrosive body, aluminum flooring, rear door should be of two pieces with looking arrangement
 - (xiii) Wheel :- 4+1
 - (xiv) Electric System 12 volt battery 70 AH capacity enough for vehicle lightning and cabin equipment to work
 - (xv) Bharat Stage III /IV Turning Radius min.5.5 metres

2. Fabrications/Additions

- (i) Complete AC fitting sufficient for the vehicle (Subros)
- (ii) Power Steering (ZF)/Power windows
- (iii) Fabrication of Interior (Medicine Cabinets with shelves inside for storage of medicines, Stainless Steel Wash basin with tap, Seating arrangement for on rear cabin, fire extinguisher 400g.)
- (iv) Exterior Design (Customized External Graphics with Hospital name, Address & logo etc as per design provided by State Health Society Bihar
- (v) Steel/metal sheet at the Top of cabinet to keep Autoclaves and equipments
- (vii) Positioning of the light needs to be shifted, if needed provision of another light
- (viii) Proposed OT table needs to be raised, should installed be in the center of the vehicle cabinet with overhead lights. Position of the over lights should be such that it focuses at both the ends of the OT table.
- viii) Curtains at all the Window, films on windows (as per government specifications)
- (ix) Stickering on Mobile IUCD Van
- (x) GPS locator on each vehicle
- (xi) Partition between the Driver's cabin and the proposed OT section
- (xii) Seating arrangements within the cabin of the vehicle needs to be made for at least three persons
- 2. The bidders shall have to furnish details of quality stipulations of equipments /Fabrications.
- 3. However, if the bidder has any authorized registered dealer/agent in the state of Bihar, no CST will be payable. If the bidder does not have any authorized dealer / agent in the state of Bihar, then CST may be payable instead of VAT.
- 4. The bidder will have to ensure free demonstration of the fabricated IUCD van at a pre-determined place after award of tender within 30 (thirty) days of the placement of work-order to satisfy its members for technical acceptability as per the tender specifications in the tender. No compromises will be made

regarding the quality, durability, & guarantee of the fabrication and equipments and tender specifications.

- 6. The purchaser will award the contract to the successful bidder depending primarily on the basis of lowest bid subject to previous experience of supplying similar vehicles by the agency with documentary proof.
- 7. The bidder will submit an undertaking on non-judicial stamp paper worth of Rs. 100/-
 - (i) The bidder will go for mutually agreed AMC for five years after the expiry of warranty period of two years.
- 8. In case, any bidder is found guilty of forging/tampering any document /certificate, the firm is likely to face legal action as per the laws. The refundable earnest money submitted with the tender may also be forfeited by the State Health Society-Bihar.
- 10. Details of documents enclosed with the tender should be mentioned in a proper Index serial wise (as per tender document) on the front page of the tender. The documents should be flagged properly
- 11. No conditional tender shall be accepted.
- 12. The approved firm/bidder shall be bound to deliver the fabricated Mobile IUCD Van within 75 (Seventy Five) days from the award of contract.
- 13. If the delivery is not effected on due date, State Health Society Bihar will have the right to impose a penalty @ 2 percent per week of the total cost of un-supplied vehicles subject to the maximum of 16%.
- 14. The successful bidder shall be responsible for execution of the supplies strictly in accordance with the contract in full and shall not in any case assign or sublet any part thereof. Deviation, if any can lead to forfeiture of earnest money or even black listing of the agency.
- 15. In case the bidder fails to demonstrate the fabricated IUCD van within the allocated timeframe, or fails to supply the fabricated IUCD vans within the delivery period, the State Health Society reserves the right to cancel the work order, and forfeit the earnest money. The action of forfeiture of earnest money may well be taken in the following cases as well:
 - a) When bidder withdraws or modifies the offer after opening of technical bids.
 - b) When bidder does not execute the agreement prescribed within the specified time.
- 16. The successful bidder is bound to supply the fabricated vans on the rates once quoted by them and approved by State Health Society, Bihar.
- 17. The approved supplier shall carefully examine the conditions, specifications, size, make, and catalogue/drawings etc. of the equipments to be supplied. In case of any doubts, he/she shall contact the concerned person at State Health Society- Bihar for clarifications.
- 18. All the terms and conditions of tender notice shall form part of the supply order/agreement even if they are not explicitly mentioned therein.
- 19. The successful bidder shall have to abide by the standard terms and conditions as laid down in the General Financial Rules, 2005 of the state and Indian Contract Act, 1872, and those of the contract/agreement to be executed.
- 20. The sample vehicles should be offered for inspection within 30 (thirty) days from the date of confirmed order, and balance vehicles should be supplied within 30 (thirty) days from the date of sample vehicles clearance.
- 21. The successful bidder will have to furnish a bank guarantee of @ 5% of the total cost of twelve (12) fabricated IUCD vans as performance guarantee valid for a period of 60 days more than that of the period of agreement.
- 22. Payment of vehicle at DGS&D rates would be made upon receipt of performa invoice. For the purpose of fabrication work, advance payment as per financial rules GFR 2005 will be given against equivalent amount of Bank Guarantee.

- 23. After clearance of sample vehicle, the manufacture/ dealer will confirm the supply to be exactly as per the sample vehicle cleared by the department. There should be no action / deviation after approval of the sample.
- 24. All the equipments supplied should be of the best quality, specification, and trademark, and in accordance with the approved standard, catalogue, and samples. Any change in the fitted equipments without approval would have to be replaced by the supplier at its own cost.
- 25. The L1 agency will have to enter into agreement with SHSB for providing maintenance of the vehicle even during the warranty period.
- 26. The bidders shall be responsible for the proper delivery of fabricated IUCD van. In the event of any loss, damage/breakage, the bidders shall be liable to make good such loss/damage found at the checking/inspection/verification of the IUCD vans by the supplier, no extra cost on such account should be admissible.
- 27. In case of any dispute/ difference or doubts between the State Health Society Bihar and the approved suppliers/ agency arises, the decision of the Principal Secretary (Health) Government of Bihar-cum-Chief Executive Officer, State Health Society Bihar shall be final and binding.
- 28. Thirty percent payment towards the cost of Mobile IUCD Van may be made in advance as against Bank Guarantee along with the work order and balance seventy percent of the cost after receipt of vehicles.
- 29. The State Health Society reserves the right to accept or negotiate as regard the reasonability of rates subject to the approval of Executive Director, State Health Society Bihar.
- 30. Logo of IUCD Van has to be superscripted on the outer body of Mobile IUCD Van in consultation with State Health Society Bihar.
- 31. Legal proceedings that may arise at any time shall be subject to the jurisdiction of Patna Courts only.
- 32. The bidders would in no case be allowed to correct or replace or vary the document/s once filed along with the bid.
- 33. An agreement will be signed with the successful bidder after final short listing and award of contract.
- 34. State Health Society reserves its right to accept or reject any or all bid/s, and vary any terms/ matter of the bid or annul the bidding process itself at any time without assigning any reason thereof.
