Air Ambulance Services in Bihar during Vidhan Sabha Elections 2015

CORRIGENDUM - 01

Based on suggestion given by Agencies present and discussion held, the committee recommends following changes in the tender:

I. The Agency is required to be airborne within 15 minutes on receiving call and reach the designated airport within 30-45 minutes, as per distance & flying time.

II. Payments: The selected agency will be paid phase wise. In each phase, 50% (fifty percent) of the total amount on arrival of Air Ambulance and the rest 50% (fifty percent) on submission of invoice after completion of work assigned. The payment shall be done within 10 (ten) working days of submission of invoice. All payments shall be made by The District Magistrate, Patna / Gaya. Funds for the same shall be provided by the Election Commission.

III. The agency is required to submit experience details in the form of affidavit **sworn before notary** as per the format given below:

Note: (i) Attach documentary evidence like work order, payment received, etc. to establish experiences gained so far.

IV. The selected agency is required to keep sufficient stock of life saving drugs & medicines required in emergency cases.

V. The dates for polling for Vidhan Sabha Election 2015 in Bihar was announced after publication of tender in newspapers. The dates are 12th, 16th, 28th October, 1st and 5th November 2015. It was informed in the meeting that all five phases of election in Bihar includes naxal affected area. Accordingly, financial offer should be suitably modified. The participating agencies suggested that offer may be demanded in two parts i.e. for (i) Phase 1 & 2, and (ii) Phase 3,4 & 5. Considering the suggestions given by participating Agencies, the financial offer has been modified as below:



- (iv) The Bidder quoting lowest '**Total Bid Amount**' - **sum of Table – A (V) and Table – B (V)** as per tables above will be considered as L1 and will be awarded the contract.

2. Modification / changes as above shall be binding on all the bidders.
