**Tender Notice**

State Health Society, Bihar invites tender from Khadi/Handloom Primary weavers co-operative societies / Handloom Unions / State Handloom Corporation / SSI units dealing with Handloom / NGOs dealing with Handloom and belonging to Bihar state for rate contract for the supply of coloured chadars to Medical college, District, Sub-divisional, Referral & PHC hospitals.

Agencies wishing to undertake the above task, may submit their tender in a large envelope marked "Tender for supply of Satrangi Chadar" and addressed to "The Executive Director, State Health Society Bihar, Pariwar Kalyan Bhawan, Sheikhpura, Patna-800014" must reach latest by 3:00 PM on 14.09.2015 through Registered/Speed Post. This large envelope will contain two separate sealed envelopes marked as Cover 'X' for technical bid and marked as Cover 'Y' for financial bid with sample of Satrangi Chadar. In the event of the specified deadline of submission of tenders being declared a holiday, the tenders shall be received on the next working day.


All the technical bids will be opened on 16.09.2015 at 3.00 PM at SHSB in the presence of the parties.

Financial bids of the technically qualified bidders will be opened on 22.09.2015 at 3.00 PM at SHSB in the presence of the parties.

- The State Health Society, Bihar reserves the right to accept any or reject any or all EoI without assigning any reason.

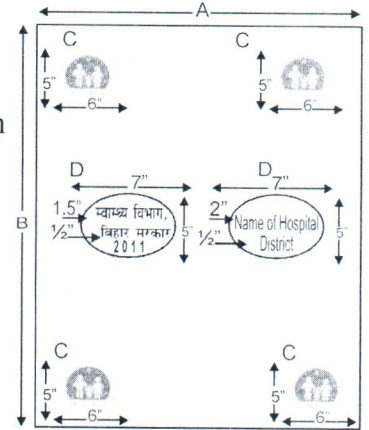

**Specification for Hospital Coloured Chadar, Size – 96" x 54" & 110" x 60"**

**Common specifications for both sizes:-**

1. Size of coloured Chadar : 96"x 54" ± 5% variation  
110" x 60" ± 5% variation
2. (i) Ends / inch : 36 ± 5% variation  
(ii) Picks / inch : 32 ± 5% variation  
(iii) Selvedge ends / inch : 72 ± 5% variation
3. (i) Count of warp yarn : 2/20<sup>S</sup> or 17 NF  
(ii) Count of weft yarn : 2/20<sup>S</sup> or 17 NF  
(iii) Count of Selvedge Chadar : 2/20<sup>S</sup> or 17 NF
4. Shrinkage % of warp weft and selvedge yarn : 5%



A = 54" or 60"  
B = 96" or 110"  
C = 6' x 5"  
D = 7" x 5"

5. Coloured Chadar will be in seven different colours i.e. Green, Yellow, Sky Blue, Indigo, Orange, Blue & Red (Brand of colour will be VAT).
6. Logo of National Rural Health Mission in 6" x 5" will be screen printed with indelible black colour ink on all four corners of Chadar. (For reference please see the design on right side of tender notice).
7. Stamping of Department of Health Services (in 1.5" letter size), Govt. of Bihar (in 1/2" letter size) & year of manufacturing on the left side and name of the Hospital (in 2" letter size) & District (in 1/2" letter size) on right side will be printed by hand block with indelible black colour ink in oval shape of 7" x 5" diameter at the centre of Chadar in two separate blocks side by side. (For reference please see the design on the right side of tender notice).

**Particular specification for 96" x 54" size chadar :-**

Weight : 550 gms. 5% variation

**Particular specification for 110" x 60" size chadar:-**

Weight : 670 gms. 5% variation

**Minimum Eligibility Criteria:**

Interested Khadi / Handloom weavers may submit their EOI in sealed envelope marked "Expression of Interest for Hospital Coloured Chadar" which will contain all the following mentioned necessary documents:

1. Audit report of last three consecutive financial year 2012-13, 2013-14 & 2014-2015 with minimum annual turnover of Rs. 5 lacs.
2. Self certified duly filed Income Tax Return for the last three year, i.e. AY 2014-15, AY 2013-14 and AY 2012-13
3. Affidavit – Self / Notarized stating that it is not black listed by any agency or has pending case either Civil or Criminal against them.
4. EMD of Rs. 25000/- (Rupees twenty five thousand only) (Refundable) in the form of Demand Draft favouring "Executive Director, State Health Society, Bihar, Patna".

**Evaluation of Technical EOI :**

The firm needs to satisfy the Minimum Eligibility Criteria for being technically qualified is as follows:

**Tender conditions:**

- (a) A pre-bid meeting will be held on 04.09.2015 with the intending bidders at 11.30 AM at the conference hall SHSB.
- (b) The bidders will be required to submit one number of sample of each coloured Chadar on the basis of the technical specifications advertised.
- (c) The selected agency shall have to ensure that the sample of coloured hospital Chadar is made of Handloom /Khadi and is produced by the Handloom weavers of Bihar. A certificate of the same shall have to be furnished by the tenderer.
- (d) Dyeing and screen printing of logo of National Health Mission (NHM) and Hand block printing of Health Department, Govt. of Bihar and name of District Hospital will be done by SSI registered Rangrej Artisan having minimum two years experience in the field. A certificate of the same will be submitted along with the sample confirming that the Dyeing and printing are done by the Rangrej Artisan.
- (e) The technical bid will be opened on 16.09.2015 at 3.00 PM where in one sample will also be selected as submitted by the bidders.
- (f) The manufactures which fulfil the minimum technical eligibility criteria as above will be considered for opening at financial bids.
- (g) The bidder will quote the rate under following format-

- (h) The agency who has the L1 rate will be asked to supply coloured Hospital Chadars. If the L1 agency is unable to provide the Chadars to all the Medical college, District, Sub-divisional, Referral & PHC hospitals, other agencies willing to supply at L1 rate will be given the opportunity but it will be at the sole discretion of SHSB.
- (i) The successful Agency will have to furnish a suitable performance security of 5% of the project cost at the time of awarding the rate contract for the period of the contract. The proceeds of their performance security shall be payable to SHSB as compensation of suppliers failure to fulfil its obligation under the contract or for making delay in the completion of obligations under the contract. The selected agency will be immediately informed about the final award. In case the selected agency declines to take-up the task henceforth from SHSB at the quoted and approved rated, it would be barred for 5 years since the tender publish date from applying for any tender from the State Health Society, Bihar.
- (j) The agency will be provided the list of Hospitals along with the number of Chadars required for each of the Hospital.
- (k) It will be the sole responsibility of the agency to supply the Chadar to concerned Medical colleges, District Hospitals, sub divisional hospitals, referral hospitals and PHCs matching to the sample supplied along with the certificate.
- (l) The agency will inform State Health Society, Bihar & respective District Hospital as per list of Hospitals under clause (J) one week before the supply is done.
- (m) Torn, mutilated, damaged Chadar shall not be accounted for the purpose of supply and no charges will be paid for its replacement within 15 days with no extra cost would be the responsibility of the agency.

Handwritten signatures and initials are present at the bottom of the page, including a large signature on the left and several initials on the right.

- (n) Risk, liability and insurance upto delivery at Every Hospital would be of the agency.
- (o) Transportation free of cost upto PHC Hospital would be the responsibility of the agency.
- (p) The rate contract will be applicable for three years from the date of award of the contract.

The list of L1 agency will be finalized at the State Health Society, Bihar.

**Deadline for Submission of Tender:**


The technical bid in a sealed envelope, along with the necessary documents & EMD along with one sample of Chadar must reach the office of the undersigned latest by 3.00 PM on or before 14.09.2015 through Speed Post / Registry. Tenders received after this deadline, would not be entertained. In the event of the specified deadline of submission of tenders being declared a holiday, the tenders shall be received on the next working day.

**Opening of Tenders:**

Technical bid shall be opened at 3.00 PM on 16.09.2015 in the presence of Agency or their authorized representative who desire to be present and would thereafter be evaluated by a committee of technical experts. On basis of the technically qualified tenders, the successful agency will be asked to be present during opening of financial bids on 22.09.2015.

The decision of the State Health Society, Bihar shall be final and no enquiry or application for review, shall be entertained. The State Health Society, Bihar reserves the right to cancel or reject all or any tender without assigning any reason.
