Re-Tender Notice for Supply of Various Cartridges

Sealed bids are invited from the manufacturers, authorized distributors, suppliers/original cartridge store for supply of HP Laser Jet Printer Cartridge as per requirement. Interested agencies should quote their rates typed (Hand written quotation not allowed) in the format. Bids received in any other format will not be considered. Last date for submitting the complete tender document is 14-06-2016 (3:00 PM) through Registered Post/ Speed Post. The bid shall be opened on same day (4 PM) at SHSB in the presence of the parties those who wish to participate. SHSB reserves the right to accept or reject any offer/all offers without assigning any reason. 1.Minimum Eligibility Criteria along with list of documents to be submitted in Cover 'A' (Technical Bid)

Bidders should meet the following criteria to be eligible for bidding and relevant papers/documents must be submitted by them in their technical bid in support of their eligibility for the tender.

- a) Requisite document showing three years of market standing as Cartridge supplier.
- b) Copy of VAT Registration Number of the agency.
- c) Copy of PAN Card of the agency.
- d) Self attested certificate of authorized suppliers/distributors/OCS of HP Laser Jet printer cartridge issued by the manufacturer.
- e) Minimum turnover of Eight Lacs for last three year and Average annual turnover should be of Rupees Ten Lacs (10 Lacs) for the last three financial years 2012-13, 2012-14 and 2014-15. Last three financial years Audit report duly qualified Chartered Accountant showing details (balance sheet, receipt & payment, profit & loss, income & expenditure sheet) Auditor/C.A. Certificate of turn over will not be accepted.
- f) Income tax return for last three assessment year i.e. 2015-16, 2014-15, 2013-14
- g) Bidder shall submit an affidavit sworn before First Class Magistrate stating that "the company has not been blacklisted/debarred by the Central Government/Any State Government/Semi Govt. Organization.
- h) Bidders will be required to deposit a demand draft of Rs. 25,000 (Twenty Five Thousand only) as EMD favouring State Health Society, Bihar.
- i) All the tender documents should be self attested by the tenderer.
- j) Firm Should have office in Patna.
- k) Forwarding letter indicating clearly the list of enclosures (a to j) as given in Para-1 above.

3. Submission Requirements: Interested eligible agencies, wishing to participate in the tender may submit their bids in a large envelop marked "Tender bid for Supply of Various Cartridges". This large envelop will contain two separate sealed envelopes—one marked as Cover 'A' for technical bid for supply of various cartridges and another marked as Cover 'B' for financial bid for supply of various cartridge should be submitted in separate envelops and should be marked as stated above.

4. Terms & Conditions:

- Rates quoted must be inclusive of all the taxes and shall be valid till 31.12.17. Quoted price should not exceed MRP.
- 2. The supply at SHS office should be made maximum within 10 days of receipt of supply order (excluding holiday) failing which a penalty @ 1/2% (half percent) of the total work order amount will be levied per day (subject to maximum of 10% of the rates of material supplied). All the items should be supplied to this office for which no other charges will be given.
- 3. Penalty in any term will be imposed (as decided by SHSB) for non compliance of work order.

The items supplied should be as per specification of tender.

- 4. Successful bidder shall have to furnish a suitable Performance Security for an amount Rs. 50,000/- (Fifty Thousand Only) in the form of Bank Guarantee at the time of signing of the Agreement incorporating details of the terms and conditions. The proceeds of their Performance Security shall be payable to the SHSB as compensation for failure to fulfill its obligation under the contract or for making delay in the completion of obligations under the contract. The security deposit amount shall not carry any interest and it shall be valid till 60 days beyond the end of the period of the contract.
- 5. TDS shall be deducted at prescribed norms on the payable amount as applicable.

- 6. If the agency denies/withdraw/refuses to accept the work after its selection as successful bidder, the EMD deposited will be forfeited. In the same manner if it refuses to carry out the work so allotted after signing the Agreement or for any breach of contract the Performance security will be forfeited and steps for termination/blacklisting/debarring may be taken suitable.
- 7. Jurisdiction of any dispute is Patna only.
- ** Note: Approx annual consumption of 88 A cartridges is 250 Pcs and for others it is around 10 Pcs.

5. Deadline for Submission of Bids-

Technical and financial bids, in separate sealed envelops may be sent, to "The Executive Director, State Health Society Bihar, Pariwar Kalyan Bhawan, Sheikhpura, Patna-800 014". The bids must reach the office of the undersigned latest by 3:00 P.M. on or before 14.6.16 through Registered/Speed Post. Bids received after deadline, would not be entertained. No bid will be accepted directly or by hand. SHSB will not be responsible for postal delay. In the event of the specified deadline of submission of bid being declared a holiday, the bid shall be received on the next working day.

6. Opening of Bids -

Technical bid shall be opened at <u>4 PM on last date of submission of tender i.e. 14.6.16</u> in the presence of bidders or their authorized representatives who desire to be present. After opening of the bids, all opened technical bids shall be evaluated by a committee on technical grounds. Financial bid of only those bidders will be opened, whose technical bids are found eligible by the Technical Core Committee. Financial Bid will be opened in the presence of bidders or their authorized representatives. The date of opening of financial bid will be informed to the Technically Qualified bidders.

7. Display of qualified/disqualified bidder on SHSB website: Bidders should visit SHSB website-http://statehealthsocietybihar.org regularly for information regarding status on qualification/disqualification of their bid and for other related information.

8. The decision of the State Health Society Bihar shall be final, and no enquiries, or application for review, shall be entertained. The State Health Society Bihar reserves the right to amend any of the conditions, cancel or reject all or any tender without assigning any reason.
