

राज्य के जिला मुख्यालयों में स्वयंसेवी संस्थानों/गैर सरकारी संस्थानों द्वारा “नशा मुक्ति केन्द्र” स्थापित करने के निमित्त प्रकाशित निविदा सूचना के आलोक में प्राप्त निविदाओं का तकनीकी मूल्यांकन करने हेतु तकनीकी समिति की दिनांक 18.03.2016 को आहूत बैठक की कार्यवाही

राज्य सरकार की नई उत्पाद नीति 2015 (निबंधन, उत्पाद एवं मद्य निषेध विभाग का संकल्प संख्या 11/नयी उत्पाद नीति-01-03/ 2015-3893, दिनांक 21.12.2015) के तहत राज्य में चरणबद्ध तरीके से मद्यपान निषेध लागू किया जाना है। नई उत्पाद नीति 2015 के तहत राज्य में चरणबद्ध तरीके से मद्यपान निषेध लागू करने हेतु नई उत्पाद नीति के तहत स्वैच्छिक मद्य निषेध हेतु नशा मुक्ति के उपचारार्थ आये मरीजों के गहन देखभाल एवं उनके पुर्नवास हेतु “नशा मुक्ति केन्द्र” स्थापित करने के निमित्त स्वयंसेवी संस्थानों/गैर सरकारी संस्थानों को सूचीबद्ध करने हेतु दिनांक 10.02.2016 को विभिन्न समाचार पत्रों में निविदा आमंत्रण सूचना का प्रकाशन किया गया था।

2. निविदा सूचना के अनुसार निविदा जमा करने की अंतिम तिथि तक प्राप्त कुल बाईस (22) निविदाओं का तकनीकी मूल्यांकन तकनीकी समिति की दिनांक 10.03.2016 को आहूत बैठक में की गयी थी।
3. तकनीकी समिति की उक्त बैठक में तकनीकी मूल्यांकनोपरान्त दो निविदादाताओं क्रमशः Pt. Devinath Lakshmi Narayan Samaj Kalyan Kendra, Saran (Chhapra) एवं Dr. Chandradeo Yadav Swatantra Senani Smarak Kalyan Samiti, Lakhisarai को निविदा सूचना के न्यूनतम अर्हता शर्त की basic eligibility criteria को पूरा नहीं करने के कारण तकनीकी रूप से अस्वीकृत कर दिया गया था।
4. तकनीकी समिति द्वारा उक्त बैठक में निर्णय लिया गया था कि जिन निविदादाता स्वयंसेवी संस्थानों ने निविदा सूचना के न्यूनतम अर्हता शर्त के अनुरूप सभी अभिलेखों/कागजातों को संलग्न नहीं किया है, उन्हें एक अवसर प्रदान करते हुये दिनांक 16.03.2016 के अपराह्न 04:00 बजे तक अभिलेख/कागजात/साक्ष्य प्राप्त कर लिया जाय। तकनीकी समिति की कार्यवाही की प्रति वेबसाइट पर अपलोड करते हुये निविदादाताओं से वांछित कागजात की माँग की गयी थी।
5. दिनांक 16.03.2016 तक 20 (बीस) निविदादाताओं से प्राप्त अभिलेख/कागजात/साक्ष्यों का तकनीकी मूल्यांकन किया गया। कार्यवाही के साथ एतद् संबंधी तकनीकी तुलनात्मक विवरणी संलग्न है।
6. तकनीकी समिति द्वारा तकनीकी मूल्यांकनोपरान्त पूर्व में तकनीकी रूप से अयोग्य घोषित दो निविदादाताओं के अतिरिक्त निम्नलिखित 17 निविदादाताओं को सर्वसम्मति से तकनीकी रूप से अयोग्य घोषित किया गया। जिन कारणों से निविदाओं को तकनीकी रूप से अयोग्य घोषित किया गया है उन कारणों को तकनीकी तुलनात्मक विवरणी में उद्धृत कर दिया गया है।
