- A. 

4	Page 10: Clause 15	Signing and Sealing of Tender	Inclusion Clause 15.6 <i>"The tender documents and the EMD shall be placed in two separate envelopes and shall be put in one big envelope, which shall be sealed. The envelopes shall clearly bear the following identification:</i> 'Application for Empanelment for Event Management Agency for Creative IEC Activities/Works' <i>and shall clearly indicate the name and address of the bidding Agency.
