Request for Proposal (RFP) for selection of agency for establishment of 20-seater comprehensive & integrated, 104 call centre for public health grievance, health helpline and medical advice in Bihar

The State Health Society, Bihar (SHSB), Patna intends to select agency via e-tendering for establishment of 20-seater comprehensive & integrated "104 call centre" for public health grievance, health helpline and medical advice in the state of Bihar, and invites bids from eligible organisations, in providing the services as mentioned in this Request for Proposal (RFP).
2. The Agency shall be responsible for financing, design, build, equip, operate, maintain and manage & transfer of comprehensive & integrated 104 call centre for public health Grievance, health helpline and medical advice in Bihar for the State Health Society, Bihar (SHSB), Patna.
3. 5. Tenderer may also download the tender documents (complete set of the document is available on website) from the e-procurement portal (<https://www.eproc.bihar.gov.in/BELTRON>) and submit its tender by using the downloaded document.
 6. The tender(s) shall be accompanied by **Earnest Money Deposit (EMD) of 10,00,000/- (Ten Lakhs only)** in the shape of Demand Draft (DD) from any Schedule Bank in favour of State Health Society, Bihar (SHSB) payable at

Patna. All tenders must be accompanied by EMD as mentioned. It may be noted that no bidder is exempt from deposit of EMD. Tenders without EMD shall be summarily rejected.

7. Tender processing fee (TPF) amount for the sum of Rs.1,180/- (One thousand one hundred and eighty rupees) to be paid by the bidder through e-Payment mode (i.e., NEFT – RTGS, Internet Banking, Credit/Debit Card) only, to the agency empanelled by Government of Bihar for centralized e-procurement.
8. The technical and financial bids must be submitted through e-Procurement Portal (www.eproc.bihar.gov.in/BELTRON) on or before the date and time specified in the NIT. The SHSB does not take any responsibility for the delay/ Non-submission of tender/ Non-reconciliation of online payment caused due to non-availability of internet connection, Network Traffic/Holidays or any other reason.
9. The bidders shall submit their eligibility and qualification details, certificates as mentioned in the tender document, in the online standard formats given in e-Procurement Portal (<https://www.eproc.bihar.gov.in/BELTRON>) at the respective stage(s) only.
10. The bidders shall upload the scanned copies of all the relevant certificates, documents etc., in support of their eligibility criteria/ technical bids and other certificate / documents in the e-Procurement Portal (<https://www.eproc.bihar.gov.in/BELTRON>).

11. The Bid shall be submitted online and in physical form as mentioned below: -



(2) Technical Bid	Online (Cover – Technical Stage)
(3) Financial Bid	Online (Cover – Cost Bid Stage)

12. The technical bids will be opened (in e-mode/online) on the date 27/12/2018 (Thursday) at 11:00 AM. In the event of any of the above-mentioned day being declared a holiday/closed day for the State Health Society, Bihar (SHSB), the bids will be received/opened in the next working day at the scheduled time.
13. All prospective bidders may attend the Pre-Bid (Bid-clarification) meeting. The venue, date and time are indicated in Schedule of Events as in **Clause 4** above.
14. The hard (Physical) copy of the Earnest Money Deposit (EMD), should be sent to the Executive Director, State Health Society, Bihar, Pariwar Kalyan Bhawan, Sheikhpura, Patna – 800014, by registered post/speed post or by hand. It must reach the above said address on or before the closing date & time indicated in **Clause 4** above, failing which the tenders will be treated as late tender would be summarily rejected.
15. In the event of any of the above-mentioned dates being declared as a holiday/ closed day for the State Health Society, Bihar, the tenders /EMD will be received/opened on the next working date at the scheduled time.
16. The SHSB reserves the right to accept or reject any or all tender or change the terms and conditions of the RFP or cancel the RFP without assigning any reasons at any stage and time.
