NOTICE INVITING TENDERS

1. The State Health Society, Bihar(SHSB), Patna intends to select agency via e-tendering for setting up & operationalizing 24X7 Dialysis Units through Public Private Partnership (PPP) mode in 38 Government Hospitals in the state of Bihar for the period of 5 years from the date of agreement. The State Health Society, Bihar, invites bids from eligible business entities, in providing the services as mentioned in this tender document. The key objective is to provide high quality Hemodialysis under PPP mode to the people of Bihar.
2. The Service Provider shall be responsible for Development (where "Development" means financing, design, build, equip, operate, maintain & manage) of dialysis centres in the hospitals identified by SHSB.
3. The contract with the successful agency/bidder will be signed with SHSB & DHS but day-to-day execution of the contract will be done by the District Health Society (DHS) of the concerned district, in which dialysis unit is to be set up.
4. The Bidder cannot bid for an individual government Hospital or a group of government Hospitals, but has to bid taking into consideration all the **38** government Hospitals, as mentioned in **Appendix A**, subject to all the conditions as laid down in this tender document.
5. Each Hemodialysis Unit shall have atleast five (4+1) machines.
6. 8. Tenderer may also download the tender documents (a complete set of document is available on website) from e-Procurement Portal (<https://www.eproc.bihar.gov.in/BELTRON>) and submit its tender by using the downloaded document.
9. The tender shall be accompanied by Earnest Money Deposit (EMD) of Rs. 38,00,000/- (Thirty Eight Lakhs only) for all the 38 government hospitals in the shape of Demand Draft from any Schedule Bank in favour of State Health Society, Bihar payable at Patna.

10. Tender Processing Fee (TPF) amount for the sum of Rs. 1,180/- (One thousand one hundred and eighty rupees) to be paid through e-Payment mode (i.e. NEFT-RTGS, Internet Banking, Credit / Debit Card) only, to the agency empanelled by Government of Bihar for centralized e-Procurement.
11. The technical and financial bids must be submitted through e-Procurement Portal (<https://www.eproc.bihar.gov.in/BELTRON>) before the date and time specified in the NIT. The SHSB doesn't take any responsibility for the delay / Non Submission of Tender / Non Reconciliation of online Payment caused due to Non availability of Internet Connection, Network Traffic/ Holidays or any other reason."
12. The bidders shall submit their eligibility and qualification details, Certificates as mentioned in the tender document, in the online standard formats given in e-Procurement Portal (<https://www.eproc.bihar.gov.in/BELTRON>) at the respective stage(s) only.
13. The bidders shall upload the scanned copies of all the relevant certificates, documents etc., in support of their eligibility criteria / technical bids and other certificate /documents in the e-Procurement Portal (<https://www.eproc.bihar.gov.in/BELTRON>).
14. The Bidding documents shall be submitted in the mode as mentioned below:

(1) Earnest Money Deposit (EMD)	Physical (Offline Mode) Note: EMD should not have been issued on a date later than the last date for submission of online bidding document i.e., 30/08/2018 (Thursday).
(2) Technical Bid	Online (Cover-Technical Stage)
(3) Financial Bid	Online (Cover-Cost Bid Stage)

15. The technical bids will be opened (in e-mode/online) on the date **07/09/2018(Friday) at 11:00 AM**. In the event of any of the above-mentioned day being declared a holiday/closed day for the State Health Society, Bihar (SHSB), the bids will be opened in the next working day at the scheduled time.
16. The bids must be uploaded (e-mode/online) at the e-Procurement Portal (<https://www.eproc.bihar.gov.in/BELTRON>).
17. All prospective tenderers may attend the Pre-Tender meeting. The venue, date and time are indicated in Schedule of Events as in **Clause 7** above.
18. The hard(Physical) copy of the Earnest Money Deposit (EMD), should be sent to **The Executive Director, State Health Society, Bihar, Pariwar Kalyan Bhawan, Sheikhpura, Patna-800014** by Registered Post/ Speed Post or by hand. It must reach the above said address on or before the closing date & time indicated in **Clause 7** above, failing which the tenders will be treated as late tender and would be summarily rejected.
19. In the event of any of the above mentioned dates being declared as a holiday/ closed day for the State Health Society, Bihar the tenders/EMD will be received/opened on the next working day at the scheduled time.
20. All Tenders must be accompanied by EMD as mentioned. No bidder is exempted from submitting of EMD as mentioned in the tender document.Tenders without EMD shall be summarily rejected.
21. SHSB reserves the right to accept or reject any or all tender or change the terms and condition of NIT or cancel the NIT without assigning any reasons at any stage and time.
