## **NOTICE INVITING TENDER**

- 1. The State Health Society, Bihar(SHSB), Patna intends to select agency via e-tendering for setting up & providing X-ray services in District Hospitals, Sub-Divisional Hospitals& Referral Hospitals; and teleradiology services for DHS operated X-ray centres on Hub and Spoke model under Public Private Partnership (PPP) mode, in the state of Bihar, for the period of 5 years from the date of agreement. The State Health Society, Bihar(SHSB) invites bids from eligible business entities, in providing the services as mentioned in this tender document. (Note: For the purpose of this tender, the terms, agency/ bidder/consortium/ service provider/ tenderer/applicant shall all denote the same, if not stated otherwise.) in clusters (of districts), as mentioned in the tender document.
- 2. The selected agency shall be responsible for Development (where "Development" means financing, design, build, equip, operate, maintain & manage) of X-ray services in DH, SDH& RH in allocated group of districts.
- 3. The service provider shall be required to do undertake these activities in allocated group of districts:
  - 3.1 In the government healthcare facilities, where X-ray units are to be established, it shall be required to undertake a gap assessment cum compliance study as per Atomic Energy Regulation Board (AERB) Regulations (Atomic Energy (Radiation Protection) Rules, 2014) as amended from time to time, and upgrade the infrastructure in the healthcare facilities in compliance to it.
  - 3.2 Procurement and installation of X-ray machines of the required specifications, as mentioned in the tender document— Digital X-ray in District hospitals and Computerized X-Ray machines in Subdivisional hospitals& Referral Hospitals.
  - 3.3 Accountable and responsible for getting "License for operation" from AERB for the equipment's and all the relevant government healthcare facilities, where X-ray units are to be established ,as well as for renewal of licenses from AERB, for the period of the contract.
  - 3.4 Establish tele-radiology network for digitization, transmission and reporting of X-rays and ensuring availability of qualified personnel including Radiologists for preparing the reports based on the X-ray images and delivering it to the facility. Provide digital infrastructure/ IT based solutions (for transferring images to radiologists) at all government healthcare facilities where all the X-ray units are to be established as mentioned in Appendix D.
  - 3.5 Maintain and manage all the concerned facilities and provide qualified manpower/technicians, including X-ray technicians for facilities and radiologists for preparing reports based on the X-ray images for ensuring effective operations, as per the terms and conditions mentioned in the tender document.
  - 3.6 SHSB/DHS shall install and operate X-ray units at Primary Health Centres(PHC)/ Community Health Centres(CHC), and the agency shall provide tele-radiology service (receive X-ray reports, interpret, diagnose and send back reports digitally signed by authorised qualified radiologists) for the tests conducted at these PHCs/CHCs, if required. Also, the agency shall install the required software for seamless transmission of X-Ray images from facility to the agencies' empanelled/employed radiologists.



- 4. The contract agreement with the successful agency/bidder will be signed with SHSB, and on behalf of the SHSB, the day-to-day execution of the contract will be done by the District Health Society (DHS) of the concerned districts.
- 5. The Bidder cannot bid for an individual government healthcare facility but has to bid taking into consideration all the DH, SDH& RH in the cluster of districts in which it is interested to bid, as mentioned in **Appendix D**, subject to all the conditions as laid down in this tender document.
- 6. ii) No tender will be accepted after closing date and time in any circumstances.

- In the event of any of the above-mentioned dates being declared as a holiday/ closed day for the State Health Society, Bihar the EMD/Tenders will be received/opened on the next working day at the scheduled time.
- 9. The bidder can be a sole bidder (i.e., Company/Society/Trust) or a group of legal entities (i.e., Company/Society/Trust) (maximum three) coming together as a consortium to bid for the project. The lead partner in a consortium shall have the power of attorney from all partners, constituting the consortium, for conducting all business, for and on behalf of the Consortium during the Bidding Process, including submission of Performance Security (PS) and until the appointed date under the contract agreement when all the obligations of the SPV shall become effective. However, the bidder cannot be an individual or group of individuals.
- 10. In case of consortium, all partner including the lead partner shall either have experience of operating & managing Radiology Centres (X-ray, or CT Scan or MRI), or should be a Radiology Diagnostic Equipment Manufacturer (X-ray, MRI or CT Scan) or should be a Hospital or Healthcare Service Provider experienced in performing work under health sector, combined meeting the technical eligibility criteria defined in the tender document.
- 11. Bidders may also download the tender documents (a complete set of documents is available on website) from e-Procurement Portal (<a href="https://www.eproc.bihar.gov.in/BELTRON">https://www.eproc.bihar.gov.in/BELTRON</a>) and submit its tender by using the downloaded document.

- 12. The tender must be accompanied by Earnest Money Deposit (EMD) of Rs. 10,00,000/- (Ten lakh Rupees only) per cluster (of districts), in the shape of Demand Draft from any Schedule Bank in favour of State Health Society, Bihar payable at Patna.
- 13. Tender Processing Fee (TPF) amount for the sum of Rs. 1,180/ (One thousand one hundred and eighty rupees) to be paid by the agency through e-Payment mode (i.e. NEFT-RTGS, Internet Banking, Credit/ Debit Card) only, to the agency empanelled by Government of Bihar for centralized e-Procurement.
- 14. The technical and financial bids must be submitted through e-Procurement Portal (<a href="https://www.eproc.bihar.gov.in/BELTRON">https://www.eproc.bihar.gov.in/BELTRON</a>) on or before the specified date and time as per Clause 7.2 aforesaid. The SHSB doesn't take any responsibility for the delay/ Non-Submission of Tender/ Non-Reconciliation of online Payment caused due to Non-availability of Internet Connection, Network Traffic/ Holidays or any other reason."
- 15. The bidders shall submit their eligibility and qualification details, Certificates as mentioned in the tender document, in the online standard formats given in e-Procurement Portal (<a href="https://www.eproc.bihar.gov.in/BELTRON">https://www.eproc.bihar.gov.in/BELTRON</a>) at the respective stage(s) only.
- 16. The bidders shall upload the scanned copies of all the relevant certificates, documents etc. in support of their eligibility criteria / technical bids and other certificate /documents in the e-Procurement Portal (<a href="https://www.eproc.bihar.gov.in/BELTRON">https://www.eproc.bihar.gov.in/BELTRON</a>).
- 17. The Bidding documents shall be submitted in the mode as mentioned below:

(1) Earnest Money Deposit (EMD)	Physical (Offline Mode)  Note: EMD should not have been issued on a date later than the last date for submission of online bidding document i.e., 16/04/2019 (Tuesday)

- 18. All prospective tenderers may attend the Pre-Tender meeting. The venue, date and time are indicated in Schedule of Events as in Clause 7 above.
- 19. The hard(Physical) copy of the Earnest Money Deposit (EMD), should be sent to 'The Executive Director, State Health Society, Bihar, Pariwar Kalyan Bhawan, Sheikhpura, Patna-800014' by Registered Post/ Speed Post or by hand. It must reach the above said address on or before the closing date & time indicated in Clause 7 above, failing which the tenders will be treated as late tender and would be summarily rejected. All Tenders must be accompanied by EMD as mentioned. No bidder is exempted from submitting of EMD as mentioned in the tender document.
- 20. SHSB reserves the right to accept or reject any or all tender or change the terms and condition of NIT or cancel the NIT without assigning any reasons at any stage and time.
