With reference to the Notice Inviting Tender (NIT) Reference No.- 07/SHSB/PPP(Support for Tally Software(s))/2018-19 (PR No. 13186 (NI.Ni.) 2018-19 & PR No. 14492 (NI.Ni) 2018-19) for selection of agency for providing support for renewal of annual subscription(s), upgradation, customization, training and capacity building, establishing central helpdesk and other related activities of Tally Software in government health facilities, health department offices and other government facilities working under National Health Mission (NHM) in the state, published in leading newspapers and uploaded on the website, "https://www.eproc.bihar.gov.in/BELTRON", the technical committee meeting was held on 23rd January, 2019, in the Conference Hall of the State Health Society, Bihar, Pariwar Kalyan Bhawan, Sheikhpura, Patna-14.

2. The comparative chart of the Bids submitted is annexed with the minutes of meeting. Only one bidder (M/s Shakti Infotech Pvt Ltd) out of the 3 bidders, who had applied for this tender, is found eligible. The reasons for non-eligibility of other bidders are mentioned below:

2.1 **M/s Fasttrack Advisors private limited** - The documents submitted by the bidder were submitted for an ongoing project, however the SHSB had asked information for completed projects only. Further, the documents submitted failed to clearly validate its experience of providing 150 TALLY software licenses, as per the eligibility criteria.

2.2 **M/s RASHMI INFOTECH** - The bidder failed to provide certificate of registration under Shops and Establishment Act, to the SHSB.

3. Since, minimum 2 bidders should clear the technical eligibility criteria for the financial bids to be opened, it was unanimously decided by the technical committee to cancel the existing tender (Notice Inviting Tender (NIT) Reference No.- 07/SHSB/PPP(Support for Tally Software(s))/2018-19 (PR No. 13186 (NI.Ni.) 2018-19 & PR No. 14492 (NI.Ni) 2018-19). Also, it is recommended to publish the tender again.
