

NOTICE INVITING TENDERS

1. The State Health Society, Bihar (SHSB), Patna intends to select agency via e-tendering for setting up & operationalizing advanced Interventional Cardiology Services with Cardiac Catheterization Lab (CATH Lab) facility through Public Private Partnership (PPP) mode in selected Government Healthcare facilities/Medical Colleges and Hospitals (MC&H) in the state of Bihar, for the period of 10 years from the date of agreement.
2. The State Health Society, Bihar, invites bids from eligible business entities, in providing the services as mentioned in this tender document. The key objective is to provide high quality cardiac care services under PPP mode to the people of Bihar. *(Note: For the purpose of this tender, the terms, agency/ bidder/ consortium/ service provider/ tenderer/applicant shall all denote the same, if not stated otherwise.)*
3. The Service Provider shall be responsible for Development (where "Development" means financing, design, build, equip, operate, maintain & manage) of advanced Interventional Cardiology Services with Cardiac Catheterization Lab (CATH Lab) facility in the concerned Government Healthcare facilities/ Medical Colleges and Hospitals (MC&H) in the state.
4. The State Health Society, Bihar (SHSB), shall be responsible for publication of the tender, and selection of agency/bidder for providing services, while the concerned Government Healthcare facility/ Medical College and Hospital (MC&H) shall be responsible for governing the day to day execution of the project.
5. For the purpose of this tender, the state has been divided into 7 groups, each group is having a Government Healthcare facility/ Medical College and Hospital (MC&H) acting as a Hub, where the advanced Interventional Cardiology Services with Cardiac Catheterization Lab (CATH Lab) facility shall be established, connected to network of District Hospitals (DHs) working as spokes. The Bidder shall be required to bid separately for each Group as mentioned in **Appendix-A** of tender document, subject to the conditions as laid down in the tender document. In case, the bidder intends to apply for multiple Groups, then it shall be required to provide Earnest Money Deposit (EMD) and Performance Security (PS), as applicable for the concerned Government Healthcare facilities/Medical College and Hospital (MC&H) as mentioned in the tender document(s).
6. 8. The bidder can be a sole bidder (i.e., Company/Society/Trust/ Partnership/Proprietorship) or a group of legal entities (i.e., Company/Society/Trust/Partnership/Proprietorship) (maximum three) coming together as a consortium to implement the project. The lead partner in a consortium shall have the power of attorney from all partners, constituting the consortium, for conducting all business for and on behalf of the Consortium during the Bidding Process including submission of Performance Security (PS) and until the appointed date under the contract agreement when all the obligations of the Special Purpose Vehicle (SPV) shall become effective.
9. In case of consortium, the lead partner should have experience of operating & managing advanced Interventional Cardiology Services with Cardiac Catheterization Lab (CATH Lab) facility or should be a cardiology/CATH Lab Equipment Manufacturer or should be a Hospital having advanced Interventional Cardiology Services with Cardiac Catheterization Lab (CATH Lab) facility.
10. Tenderer may also download the tender documents (a complete set of documents is available on website) from e-Procurement Portal ([https:// www.eproc.bihar.gov.in/BELTRON](https://www.eproc.bihar.gov.in/BELTRON)) and submit its tender by using the downloaded document.
11. The tender shall be accompanied by Earnest Money Deposit (EMD) of Rs. 20,00,000/- (Twenty Lakhs rupees only) per Group in the shape of Demand Draft from any Schedule Bank in favour of State Health Society, Bihar payable at Patna. All Tenders must be accompanied by EMD as mentioned above. No bidder is exempted from submitting of EMD as mentioned in the tender document. Tenders without EMD shall be summarily rejected. Also, in case the bidder has applied for multiple Groups, the bidder shall be required to submit EMD as applicable for the Groups e.g., if the bidder has applied for two Groups, then it will be Rs.40,00,000/- for three Groups, will be Rs.60,00,000/- and so on. The bidder has to explicitly mention the name of the Groups for which it is applied, in the forwarding letter of EMD to the Executive Director, SHSB.
12. Tender Processing Fee (TPF) amount for the sum of Rs. 1,180/- (One thousand one hundred and eighty rupees) to be paid by the bidder through e-Payment mode (i.e. NEFT-RTGS, Internet Banking, Credit/ Debit Card) only, to the agency empaneled by Government of Bihar for centralized e-Procurement.
13. The technical and financial bids must be submitted through e-Procurement Portal ([https:// www.eproc.bihar.gov.in/BELTRON](https://www.eproc.bihar.gov.in/BELTRON)) on or before the date and time specified in the NIT. The SHSB doesn't take any responsibility for the delay / Non-Submission of Tender / Non-Reconciliation of online Payment caused due to Non availability of Internet Connection, Network Traffic/ Holidays or any other reason."
14. The bidders shall submit their eligibility and qualification details, Certificates as mentioned in the tender document, in the online standard formats given in e-Procurement Portal ([https:// www.eproc.bihar.gov.in/BELTRON](https://www.eproc.bihar.gov.in/BELTRON)) at the respective stage(s) only.
15. The bidders shall upload the scanned copies of all the relevant certificates, documents etc., in support of their eligibility criteria / technical bids and other certificate /documents in the e-Procurement Portal ([https:// www.eproc.bihar.gov.in/BELTRON](https://www.eproc.bihar.gov.in/BELTRON)).
16. The Bidding documents shall be submitted in the mode as mentioned below:

17. The technical bids will be opened (in e-mode/online) on the date 15/01/2020 (Wednesday) at 11:00 AM. In the event of any of the above-mentioned day being declared a holiday/closed day for the State Health Society, Bihar (SHSB), the bids will be opened in the next working day at the scheduled time.

18. The bids must be uploaded (e-mode/online) at the e-Procurement Portal (<https://www.eproc.bihar.gov.in/BELTRON>).
19. All prospective tenderers may attend the Pre-Tender meeting. The venue, date and time are indicated in Schedule of Events as in **Clause 7** above.
20. The hard (Physical) copy of the Earnest Money Deposit (EMD), should be sent to The Executive Director, State Health Society, Bihar, Pariwar Kalyan Bhawan, Sheikhpura, Patna-800014 by Registered Post/ Speed Post or by hand. It must reach the above said address on or before the closing date & time indicated in **Clause 7** above, failing which the tenders will be treated as late tender and would be summarily rejected.
21. In the event of any of the above-mentioned dates being declared as a holiday/ closed day for the State Health Society, Bihar the tenders/EMD will be received/opened on the next working day at the scheduled time.
22. SHSB reserves the right to accept or reject any or all tender or change the terms and condition of NIT or cancel the NIT without assigning any reasons at any stage and time.
