NOTICE INVITING TENDER

1. The State Health Society, Bihar(SHSB), Patna intends to select agency(ies) via e-tendering for working as a Patient Provider Support Agency (PPSA) for providing Tuberculosis (TB) related services under Revised National Tuberculosis Control Program (RNTCP) in 14 districts in the state of Bihar. With the aim of increasing notification of TB patients who seek care in private sector, and ensuring successful treatment outcomes, the PPSA shall work as an interface agency between State RNTCP department, NHM, and private healthcare system, and shall be providing patient centric services for adherence management, reduction of out of pocket expenditure through an array of free diagnostics, drugs and support services like counseling till the end of the treatment. The PPSA as a package shall cover entire spectrum of services including provider management, diagnostic linkages, drug linkages, HIV testing, DST linkages, facilitating notification, provider incentives and patient support services.
2. For the purpose of this tender, the 14 districts in the state of Bihar, have been combined into 4 clusters, namely:
Cluster 1: Patna, Nalanda, Bhojpur and Gaya
Cluster 2: Bhagalpur, Munger, Katihar and Saharsa
Cluster 3: Vaishali, Samastipur and Begusarai
Cluster 4: West Champaran, Siwan and Gopalganj
The bidder/agency can bid for a maximum of two clusters. However, in case the bidder applies for two clusters, then it shall be required to submit applicable Earnest Money Deposit (EMD) and Performance Security (PS) for both the clusters separately.
3. - Tender Processing Fee (TPF)** amount for the sum of **Rs. 1,180/-** (One thousand one hundred and eighty rupees) to be paid through e-Payment mode (i.e. NEFT-RTGS, Internet Banking, Credit / Debit Card) only, to the agency (**BELTRON**) empanelled by **Government of Bihar** for centralized e-Procurement.
