

Minutes Of the Meeting Of Technical Committee held on 18.11.2020 at 11:00 A.M. for Opening and Evaluation of Technical Bids via e-Tendering for Supply, Installation & Integration, Management and Maintenance of Equipment for Virtual classrooms at ANM/GNM Schools and IGIMS College of Nursing in the state of Bihar.

1. With reference to the **Notice Inviting Tender (NIT) Reference No.: - 12/SHSB/Virtual Classroom/2020-21** for Supply, Installation & Integration, Management and Maintenance of Equipment for Virtual classrooms at ANM/GNM Schools and IGIMS College of Nursing in the state of Bihar, published in leading newspapers [PR.07263 (Ni.Ni.) 2020-21] and uploaded on the website "<http://www.eproc.bihar.gov.in/BELTRON>" and "statehealthsocietybihar.org", the meeting of Technical Committee was held on **18/11/2020 at 11.00 AM** in the Conference Hall of the 'State Health Society, Bihar (SHSB), Pariwar Kalyan Bhawan, Sheikhpura, Patna'.

3. The bid opening committee logged in the e-proc website <http://www.eproc.bihar.gov.in/BELTRON> to open the technical bids through e-tendering process. The bid opening committee informed the technical committee that there were two (2) bids submitted for the subject tender.
4. Online bids and EMD in the shape of bank draft (hard copies) were received from the following bidders:
 - (i) Infosystem and Solution Pvt. Ltd., 3rd Floor, Devendra Laxmi Complex, Saguna More, Patna-801503, Bihar
 - (ii) Graphic Trades Pvt. Ltd., C-15, S K Puri, Basawan Park Lane, Patna-800001, Bihar

5. Evaluation of Technical Bids of all the bidders has been completed by the Technical Committee. "Technical Bid Evaluation & Comparative Sheet" is hereby annexed as "Annexure-1".
6. As per "Technical Bid Evaluation & Comparative Sheet", 'M/s Graphic Trades Pvt. Ltd. Patna' meets the eligibility criteria as per the RFP. However, the other company i.e 'M/s Info system and Solution Pvt. Ltd. Patna' doesn't meet the eligibility criteria as per the RFP. Since only one bidder is competing the eligibility it's not advisable to open the financial bid.
7. The technical committee recommends to cancel the tender.
