NOTICE INVITING TENDERS

1. The State Health Society, Bihar (SHSB), Patna intends to select agency via e-tendering for providing free pathology services under Public Private Partnership (PPP) mode, in the state of Bihar, for a period of 5 years from the date of signing of contract agreement. The State Health Society, Bihar (SHSB) invites bids from eligible business entities, in providing the services as mentioned in this tender document.
2. The selected agency shall be responsible for establishment of mini labs at District hospitals (DH), Sub-Divisional Hospitals (SDH) & Referral Hospitals (RH) and establish additional major/hub labs at district/divisional level, as defined in tender document.
3. The service provider shall be required to undertake these activities:
 - 3.1 Establishment of pathology laboratories at the DHs and SDHs, including infrastructure upgradation (if required), equipment procurement and installation etc.; and placement of phlebotomists for collection points at DHs, SDHs and RHs.
 - 3.2 Maintain and manage all the concerned facilities and provide qualified manpower/ phlebotomists/ pathologists/ lab technicians for labs and phlebotomists for sample collection, as per the terms and conditions mentioned in the tender document.
4. The contract agreement with the successful agency/bidder will be signed with SHSB, and on behalf of the SHSB, the day-to-day execution of the contract will be done by the District Health Society (DHS) of the concerned districts.
5. The Bidder cannot bid for an individual government healthcare facility, but has to bid taking into consideration all the DH, SDH & RH, as mentioned in **Appendix D**, subject to all the conditions as laid down in this tender document.
6. 

8. In the event of any of the above-mentioned dates being declared as a holiday/ closed day for the State Health Society, Bihar the EMD/Tenders will be received/opened on the next working day at the scheduled time.
9. Bidders may also download the tender documents (a complete set of documents is available on website) from e-Procurement Portal (<https://www.eproc.bihar.gov.in/BELTRON>) and submit its tender by using the downloaded document.
10. The tender must be accompanied by Earnest Money Deposit (EMD) of Rs. 50,00,000/- (Fifty lakh Rupees only) in the shape of Demand Draft from any Schedule Bank in favour of State Health Society, Bihar payable at Patna.
11. Tender Processing Fee (TPF) amount for the sum of Rs. 1,180/- (One thousand one hundred and eighty rupees) to be paid by the agency through e-Payment mode (i.e. NEFT-RTGS, Internet Banking, Credit/ Debit Card) only, to the agency empanelled by Government of Bihar for centralized e-Procurement.
12. The technical and financial bids must be submitted through e-Procurement Portal (<https://www.eproc.bihar.gov.in/BELTRON>) on or before the specified date and time as per Clause 7.2 aforesaid. The SHSB doesn't take any responsibility for the delay/ Non-Submission of Tender/ Non-Reconciliation of online Payment caused due to Non-availability of Internet Connection, Network Traffic/ Holidays or any other reason.
13. The bidders shall upload the scanned copies of all the relevant certificates, documents etc. in support of their eligibility criteria/ technical bids and other certificate/documents in the e-Procurement Portal (<https://www.eproc.bihar.gov.in/BELTRON>).
14. The Bidding documents shall be submitted in the mode as mentioned below:

The hard(Physical) copy of the Earnest Money Deposit (EMD) should be sent to 'The Executive Director, State Health Society, Bihar, Pariwar Kalyan Bhawan, Sheikhpura, Patna-800014' by Registered Post/ Speed Post or by hand. It must reach the above said address on or before the closing date & time indicated in **Clause 7** above, failing which the tenders will be treated as late tender and would be summarily rejected. All Tenders must be accompanied by EMD as mentioned. No bidder is exempted from submitting of EMD as mentioned in the tender document.
17. SHSB reserves the right to accept or reject any or all tender or change the terms and condition of NIT or cancel the NIT without assigning any reasons at any stage and time.
