e-tender (NIT) Reference No.: 01/ SHSB/ PPP/ Free Pathology Services/ 2021-22

NOTICE INVITING TENDERS

1. The State Health Society, Bihar (SHSB), Patna intends to select one/ two agencies via e-tendering for providing free pathology services under Public Private Partnership (PPP) mode, in the designated clusters (of districts) in the state of Bihar, for a period of 5 years from the date of signing of contract agreement. The State Health Society, Bihar (SHSB) invites bids from eligible business entities, in providing the services as mentioned in this tender document. (Note: For the purpose of this tender, the terms agency/selected agency/ bidder/consortium/ service provider/ tenderer/ applicant shall all denote the same, if not stated otherwise.)
2. The state is segmented into two clusters of districts, for which one/two agencies will be selected to deliver the required pathology services. Note: Same agency may be selected for delivering services in both the clusters.
3. The selected agency will be responsible for establishment of Mini-Labs/ Major Labs/Hub Labs and Apex Labs in District hospitals (DH), Sub-Divisional Hospitals (SDH) and private rented space, as defined in the tender document; and provide pathology services through these labs as per the terms defined in the tender document.
4. The service provider shall be required to undertake these activities:
 - 4.1. Establishment of Greenfield/ Brownfield pathology laboratories at the designated DHs & SDHs, and few outside the facilities, in designated clusters, including infrastructure upgradation (if required), equipment procurement and installation etc.; and placement of phlebotomists for collection of samples at DHs & SDHs.
 - 4.2. Maintain and manage all the aforementioned lab facilities and provide qualified manpower/ phlebotomists/ pathologists/ lab technicians for these labs and phlebotomists for sample collection, as per the terms and conditions mentioned in the tender document.
 - 4.3. Providing the required sample collection consumables (syringes and vials), storage equipment for samples and any other additional requirement for safe storage of samples to CHC/PHC/UPHC/UCHC , pick-up samples atleast once daily from CHC/PHC/UPHC/UCHC and conduct subsequent steps i.e. sample analysis, report generation etc., as per the terms and conditions mentioned in the tender document.
5. The bidder can be a sole bidder (i.e. Company/Society/Trust/LLP) or a group of legal entities (i.e. Company/Society/Trust/LLP) represented by a lead partner coming together as a consortium to implement the project. In case of consortium, all the partners should have experience in medical laboratory services.
6. The contract agreement with the successful agency/ bidder will be signed with SHSB, and on behalf of the SHSB, the day-to-day execution of the contract will be done by the District Health Society (DHS) of the concerned districts.
7. The Bidder cannot bid for an individual government healthcare facility in a cluster, but has to bid taking into consideration all the DH, SDH, CHCs, PHCs, UPHCs & UCHCs in the concerned cluster, as mentioned in **Appendix D**, subject to all the conditions as laid down in this tender document.
8. 10. In the event of any of the above-mentioned dates being declared as a holiday/ closed day for the State Health Society, Bihar the EMD/ Tenders will be received/ opened on the next working day at the scheduled time.

11. Bidders may also download the tender documents (a complete set of documents is available on website) from e-Procurement Portal (<https://www.eproc.bihar.gov.in/BELTRON>) and submit its tender by using the downloaded document.

12. The tender must be accompanied by Earnest Money Deposit (EMD) of **Rs. 65,00,000/- (Sixty-Five Lakh Rupees only) per cluster (of districts)** in the shape of Demand Draft from any Schedule Bank in favour of "The Executive Director, State Health Society, Bihar" payable at Patna, or transferred directly to the bank account of the SHSB, through NEFT/ RTGS/ UPI etc. In addition, if bidding for both the two clusters (of districts), the bidder should submit two separate EMD (single Demand Draft) of **Rs. 65,00,000/- (Sixty-Five Lakh Rupees only) per cluster (of districts)**.



Tender Processing Fee (TPF) amount for the sum of Rs. 1,180/- (One thousand one hundred and eighty rupees) per cluster to be paid by the agency through e-Payment mode (i.e. NEFT-RTGS, Internet Banking, Credit/ Debit Card) only, to the agency empanelled by Government of Bihar for centralized e-Procurement.

15. The technical and financial bids must be submitted through e-Procurement Portal (<https://www.eproc.bihar.gov.in/BELTRON>) on or before the specified date and time as per Clause 9.2 aforesaid. The SHSB doesn't take any responsibility for the delay/ Non-Submission of Tender/ Non-Reconciliation of online Payment caused due to Non-availability of Internet Connection, Network Traffic/ Holidays, or any other reason.
16. The bidders shall upload the scanned copies of all the relevant certificates, documents etc. in support of their eligibility criteria/ technical bids and other certificate/ documents in the e-Procurement Portal (<https://www.eproc.bihar.gov.in/BELTRON>).
17. The Bidding documents shall be submitted in the mode as mentioned below:

18. All prospective tenderers may attend the Pre-bid meeting. The venue, date and time are indicated in Schedule of Events as in **Clause 9** above.

In case of Earnest Money Deposit (EMD) submission through Demand Draft, the hard copy (Physical) should be sent to 'The Executive Director, State Health Society, Bihar, Pariwar Kalyan Bhawan, Sheikhpura, Patna-800014' by Registered Post/ Speed Post or by hand. It must reach the above said address on or before the closing date & time indicated in **Clause 9** above, failing which the tenders will be treated as late tender and would be summarily rejected. All Tenders must be accompanied by EMD as mentioned. No bidder is exempted from submitting of EMD as mentioned in the tender document.
