उपर्युक्त प्रसांगिक विषयक के संदर्भ में सूचित करना है कि भारत सरकार द्वारा वित्तीय वर्ष 2016-17 हेतु राष्ट्रीय स्वास्थ्य मिशन अंतर्गत गठित, जिला सतर्कता एवं निगरानी समिति की त्रैमासिक बैठक निगरानी समिति, ग्रामीण विकास विभाग के साथ आयोजित करने से संबंधित निदेश प्राप्त हुआ है, जो निम्नवत है-

3. जैसा कि आप सभी अवगत हैं कि सम्पूर्ण राज्य में पंचायत चुनाव संबंधित अचार संहिता लागू होने के कारण प्रथम त्रैमासिक (अप्रैल-जून 2016) बैठक मई 2016 के अंतिम शनिवार तक नहीं हो पायी है।

4. उक्त के आलोक में अनुरोध है कि प्रथम त्रैमासिक बैठक माह जून 2016 के अंतिम सप्ताह तक आवश्यक रूप करा ली जाय तथा वस्तुस्थिति से अधोहस्ताक्षरी को भी अवगत कराया जाय ताकि राष्ट्रीय मिशन को गति मिल सके।

Recently, in an interaction of Hon'ble Minister of Health & Family Welfare with Members of Parliament (MPs), it was informed that meetings of the District/City Level Vigilance & Monitoring Committees (D/CLVMCs) are not being held regularly. Further, it was also highlighted that in certain cases the District Magistrates have not attended these meetings.

In this regard, various advisories from this Ministry have been sent for holding regular meetings of D/CLVMCs in all the Districts of your State as per Guidelines. Further, to facilitate regular meetings and for convenience of participants, the schedule of D/CLVMCs of NHM was aligned with that of Vigilance & Monitoring Committees (VMCs) constituted by Department of Rural Development, vide letter No.Z.18015/6/2008-NRHM-II dated 9<sup>th</sup> January, 2016 (copy enclosed). However, as per reports received from your State, a total of only 11 meetings were held during 2015-16 (upto December 2015) as against the required number of 114 meetings.

This is a serious issue and merits your personal attention. For 1<sup>st</sup> Quarter of current Financial Year, i.e April-June, 2016, the D/CLVMC meetings are to be held on **last Saturday of May 2016** – as per the schedule shared with your State. You are requested to ensure that this schedule is adhered to in all the districts of your State.

I will appreciate if a report regarding the D/CLVMC meetings held in each of your district during the current quarter is sent by 1<sup>st</sup> week of July.

Vide numerous communications of even no., inter alia dated 13<sup>th</sup> August 2014, 28<sup>th</sup> August 2014, 16<sup>th</sup> October 2014, 22<sup>nd</sup> January 2015, 20<sup>th</sup> March 2015, and 03<sup>rd</sup> December 2015 you have been continually advised to hold regular Quarterly meetings of District Level Vigilance and Monitoring Committees (DLVMC) in all the Districts of your State – as required under DLVMC Guidelines under National Health Mission (NHM).

2. However, it has been observed that despite repeated requests DLVMC meetings are not being held regularly in all the districts in your State. This is a very serious matter and deserves your personal attention.
3. Being a critical institution for effective supervision, monitoring and accountability to ensure that the Mission activities are carried out effectively as per the felt needs of the local population, effective functioning of DLVMC assumes added importance.
4. Hence, it has been decided that the Districts should hold the DLVMC meetings on fixed dates as under:

Quarter	DLVMC Meeting Schedule
I (April - June)	Last Saturday of May
II (July - September)	First Saturday of August
III (October - December)	First Saturday of November
IV (January - March)	First Saturday of February

5. For ease of organizing these meetings, the above dates have been kept the same as that of meetings for the Vigilance and Monitoring Committees constituted by the Department of Rural Development, Government of India. However, if for any reason, the meeting is not held on the given date, then the meeting should be held within a month, as an adjourned meeting, on a date to be decided by the Member Secretary in consultation with the Chairperson.




6. I, again urge you to instruct and ensure that DLVMCs meetings are held as per the above schedule in every District of your State. A copy of the communication issued to the District authorities may also be marked to the Members of Parliament of your State.
